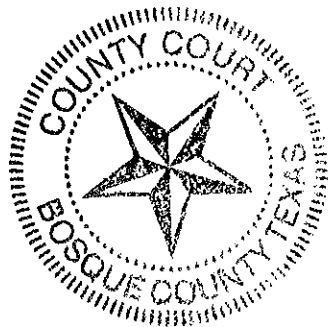

APPLICATION TO DECLARE HEIRSHIP

TO THE HONORABLE JUDGE OF SAID COURT:

The undersigned Applicant files this Application for Administration of the property and Estate of ELTON DOYLE WALLER, Decedent, and for Letters of Independent Administration and to Determine Heirship:

1. To Applicant's best knowledge and belief, ELTON DOYLE WALLER, "Decedent", died without a Will.
2. Applicant, WENDY DOYLENE ALLEN, is an individual interested in this Estate, domiciled in and residing at 117 CR 1248, Kopperl, Bosque County, Texas 76652. The last three digits of the Social Security number of WENDY DOYLENE ALLEN are XXX-XX-X935. Applicant is the surviving daughter of the Decedent and Applicant is entitled to first priority under Section 304.001 of the Texas Estates Code along with Applicant's brother and sister.
3. Applicant expects that Applicants brother and sister who are Michael Shane Waller and Kimberly Renee Gaida will consent to the appointment of Applicant as sole Independent Administrator of the Decedent's estate without bond.
4. Decedent died on May 1, 2020 in Fort Worth, Tarrant County, Texas, at the age of 85 years.
5. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence at 152 CR 1244, Kopperl, Bosque County, Texas 76665 on the date of his death.
6. Decedent owned real and personal property described generally as cash, real estate, and personal effects, of a probable value of \$75,000.00.

7. A necessity exists to determine Heirship of the Decedent and for the administration of Decedent's property and Estate to consider payment of claims, and to resolve other matters which require the authorization of a personal representative in settling Decedent's estate.
8. Applicant is qualified and not disqualified by law from serving as Sole Administrator of Decedent's Estate.
9. Applicant requests that this Court, upon notice and hearing as required by law, appoint WENDY DOYLENE ALLEN, as Independent Administrator, without bond or with bond (if required by the Court), and for such other and further orders appropriate to this Estate.



Three children were born to their marriage who are WENDY DOYLENE ALLEN, MICHAEL SHANE WALLER, and KIMBERLY RENEE GAIDA. No other children were born to or adopted by the Decedent and no other child other than the three aforementioned children resided in the home of the Decedent
12. So far as known to Applicant, there are NO other heirs of the Decedent except as named herein.

Applicant prays that citation issue as required by law to all persons in this Estate; and to all unknown heirs, if any, that Letters granting Independent Administration (with or without bond as the court may determine) be issued solely to Applicant; that the Court declare Applicant and Decedent's children (named above) to be the heirs of the Decedent; and that all other Orders be entered as the Court may deem proper.


