

**AMENDED APPLICATION FOR PROBATE OF WILL  
AND FOR ISSUANCE OF LETTERS TESTAMENTARY**

TO THE HONORABLE JUDGE OF SAID COURT:

CHARLA LEA BELL hereinafter called "Charla" furnishes the following information to the Court for the probate of the written Will of CYNTHIA JANE MOORE, ("Decedent") and for issuance of Letters Testamentary to Applicant:

1. CHARLA LEA BELL is a qualified person to serve as Independent Executor in this Estate, domiciled and residing at 224 PR 1112, Meridian, Texas 76665. The last three digits of, CHARLA LEA BELL's social security number are xxx-xx-x776.
2. Decedent died on July 23, 2018 in Meridian, Bosque County, Texas, at the age of 80 years. The last three digits of Decedent's social security number are xxx-xx-x713.
3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence at, 224 PR 1112, Meridian, Bosque County, Texas on the date of Decedent's death.
4. Decedent owned real and personal property described generally as a home that burned on 35 acres of land with a barn of a probable value of \$60,000.00.
5. Decedent left a valid written Will ("Will") dated December 29, 2016 which was never revoked and is filed herewith.
6. The subscribing witnesses to the Will are Megan Tims whose present address is unknown and Don Ellyson whose present address is unknown and the Will is self proved.
7. No child or children were born to or adopted by Decedent after the date of the Will.

8. Decedent was married once and one time only to Omer Andrew Moore and two (2) children were born to that marriage. No other children were born to or adopted by Decedent.
9. No marriage of the Decedent was dissolved after the date of the Will (See Section 256.052 Estates Code).
10. A necessity exists for the administration of this estate.
11. Decedent's Will named GARRY DON MOORE to serve as Independent Executor without bond or other security but it is expected that the sole beneficiary of the Will, who is GARRY DON MOORE, will file a waiver of his right to serve in favor of the appointment of CHARLA LEA BELL, as a successor Independent Executor. It is expected that the Court will further find that CHARLA LEA BELL is a suitable person to serve as Independent Executor of the Decedent's Estate.

It is further anticipated that the evidence will show that JACOB MICAH MOORE, is the grandson of the Decedent is in the Armed Forces of the United States and cannot serve as alternate Independent Executor since his location and duties are deemed confidential by the United State of America.

12. Decedent's Will did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

Applicant prays that citation issue as required by law to all persons in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to CHARLA LEA BELL as Independent Executor without bond; and that all other orders be entered as the Court may deem proper.
