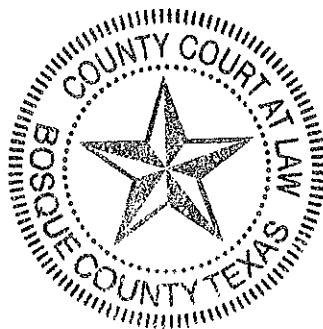

**APPLICATION FOR PROBATE OF WILL AND

TO THE HONORABLE JUDGE OF SAID COURT:

SABRE L. SABO (“APPLICANT”) furnishes the following information to the Court for the probate of the written Will of SANDRA N. HERNDON (“DECEDENT”) and for the issuance of Letters Testamentary to APPLICANT.

1. APPLICANT is the daughter of DECEDENT and is the individual who is named as the Independent Executrix in DECEDENT’s Will. SABRE L. SABO is a resident of and domiciled in the State of Texas and may be served with citation at 612 County Road 1135, Morgan, Texas 76671.

2. The last three numbers of SABRE L. SABO’s driver’s license number are 913, and the last three numbers of SABRE L. SABO’s social security number are 639.

3. DECEDENT died on October 23, 2020, in Waco, McLennan County, Texas, at the age of 73 years.

4. The last three numbers of Decedent’s driver’s license number are 673, and the last three numbers of Decedent’s social security number are 048.

5. The Court has jurisdiction and venue because DECEDENT was domiciled and had a fixed place of residence in Bosque County, Texas, on the date of her death.

6. DECEDENT owned real and personal property described generally as real estate, cash, household goods and personal effects of a probable value in excess of \$25,000.00.

7. DECEDENT left a valid written Will dated April 13, 2018, which was never revoked and is filed herewith.

8. The Will was signed and attested by two credible witnesses in Dallas County, Texas on April 13, 2018. The names of the two subscribing witnesses are Rick Howard and Rachel Fairchild.

The Will was made self-proved in accordance with Texas law with Marcia M. Fisher being the Notary Public in and for the State of Texas who took the sworn acknowledgment of the above named two witnesses to their having witnessed the execution of the Will by DECEDENT.

9. No child or children were born to or adopted by DECEDENT after the date of the Will.

10. DECEDENT never had a marriage dissolved after the Will was made.

11. A necessity exists for the administration of this Estate.

12. DECEDENT's Will names APPLICANT to serve without bond as Independent Executrix and directs that no other action be had in the Court in relation to the settlement of the Estate other than the probating and recording of the Will and the return of an inventory and appraisal of the Estate and list of claims. APPLICANT requests that the Court appoint her to serve without bond or other security as Independent Executrix of this Estate. In this regard, SABRE L. SABO is not disqualified by law from serving as Independent Executrix or from accepting Letters Testamentary, and APPLICANT is entitled to such Letters.

13. Neither the State of Texas, a governmental agency of the State of Texas nor a charitable organization is named by the Will as a devisee.

Wherefore, the APPLICANT prays that citation be issued as required by law to all persons interested in this Estate, that the Will be admitted to probate, that Letters Testamentary be issued to APPLICANT as Independent Executrix without bond or other security, and that all other orders be entered as the Court may deem proper.
