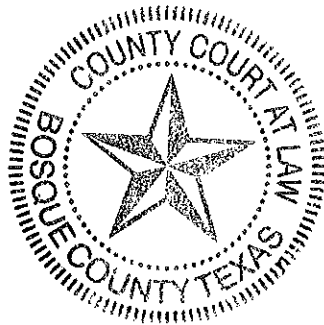


All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.

TO THE HONORABLE JUDGE OF SAID COURT:

RONALD CURTIS WIRZ ("Applicant") furnishes the following information to the Court for the probate of the written Will (Exhibit "A") of IRIS DENTON WIRZ ("Decedent") and for issuance of Letters Testamentary to Applicant:


1. Applicant, RONALD CURTIS WIRZ is an individual interested in this Estate, domiciled and residing at 1289 CR 2850, Kopperl, Texas 76652. The last three digits of, RONALD CURTIS WIRZ's social security number are xxx-xx-x750.
2. Decedent died on November 9, 2020 in Kopperl, Bosque County, Texas, at the age of 80 years. The last three digits of Decedent's social security number are xxx-xx-x946.
3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence at, 1289 CR 2850, Kopperl, Bosque County, Texas on the date of Decedent's death.
4. Decedent owned real and personal property described generally as a home, a vehicle, household goods, and personal effects, of a probable value of \$100,000.
5. Decedent left **two** duplicate original valid written Wills (Exhibit "A" and Exhibit "B") both dated March 18, 2004 which were never revoked and are filed herewith.
6. The subscribing witnesses to both of the Wills are Jane Richards whose present address is unknown and L. Walklin whose present address is unknown and the Will is **not** self proved.
7. No child or children were born to or adopted by Decedent after the date of the Wills.

8. Decedent was last married Ronald C. Wirz and no children were born to that marriage. No other children were born to or adopted by Decedent.
9. No marriage of the Decedent was dissolved after the date of the Will marked (Exhibit "A") (See Section 256.052 Estates Code) except by the death of the Decedent.
10. A necessity exists for the administration of this estate.
11. Decedent's Will marked (Exhibit "A") named Applicant to serve as Independent Executor without bond or other security and Applicant would not be disqualified by law from serving as such or from accepting Letters Testamentary, and Applicant would be entitled to such Letters.
12. Decedent's Will marked (Exhibit "A") did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

Applicant prays that citation issue as required by law to all persons in this Estate; that the Will marked (Exhibit "A") be admitted to probate; that Letters Testamentary be issued to Applicant as Independent Executor without bond; and that all other orders be entered as the Court may deem proper.
