# COUNTER-APPLICATION TO PROBATE WILL AND FOR ISSUANCE OF LETTERS TESTAMENTARY

### TO THE HONORABLE JUDGE OF SAID COURT:

Judy G. Gunn ("Applicant"), furnishes the following information to the Court in support of this Application for the probate of the Will of BILLY JOE GUNN ("Decedent"), and for issuance of Letters Testamentary:

- 1. Applicant, Judy G. Gunn, is an individual interested in this Estate, being domiciled in and residing in Texas. Judy G. Gunn's address for service of citation is 9601 Panther Way, Waco, Texas 76712. The last three digits of the social security number of Judy G. Gunn are 408. The last three digits of the driver's license number of Judy G. Gunn are 418.
- 2. Decedent died on June 13, 2017, at Clifton, Bosque County, Texas, at the age of 86 years. Decedent's domicile at the time of his death was Clifton, Bosque County, Texas. The last three digits of the social security number of Decedent are 300.
- 3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of his death.
