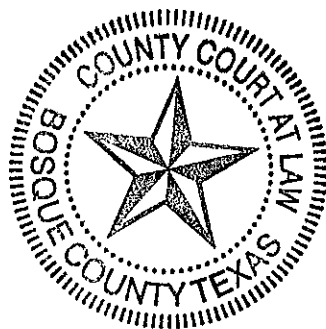

**APPLICATION TO PROBATE WILL AND
FOR ISSUANCE OF LETTERS TESTAMENTARY**

TO THE HONORABLE JUDGE OF SAID COURT:

Myron Clark Lee II ("Applicant"), furnishes the following information to the Court in support of this Application for the probate of the Will of Cynthia Marie Lee ("Decedent"), and for issuance of Letters Testamentary:

1. Applicant, Myron Clark Lee II, is an individual interested in this Estate, being domiciled in and residing in Meridian, Bosque County, Texas. Myron Clark Lee II's address for service of citation is 225 PR 2352, Meridian, Bosque County, Texas, 76665. The last three digits of the social security number of Myron Clark Lee II are 165. The last three digits of the driver's license of Myron Clark Lee II are 563.

2. Decedent died on June 29, 2021, at Clifton, Bosque County, Texas, at the age of 74 years. Decedent's domicile at the time of her death was Meridian, Bosque County, Texas. The last three digits of the driver's license number of Decedent are 517.

3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of her death.

4. Decedent owned property described generally as real estate, cash, personal effects and household goods of a probable value in excess of \$175,000.00.

5. Decedent left a valid Will dated July 25, 2007, which was never revoked. A true

and correct copy of the Will is attached. The Will will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.


6. A necessity exists for the administration of the Estate.
7. After the date of the Will, no child was born to or adopted by Decedent.
8. No marriage of the Decedent was ever dissolved after the will was made.
9. Decedent's Will named Myron Clark Lee II to serve as Independent Executor to act independently. Myron Clark Lee II resides in Meridian, Bosque County, Texas.. Myron Clark Lee II is not disqualified by law from serving as such or from accepting Letters Testamentary, and is entitled to such letters.

10. No state, governmental agency of the state, nor charitable organization is named by the Will as a devisee.

11. The Will was made self-proved in the manner prescribed by law and the subscribing witnesses to the Will are Tommy P. Herring, and Dick Kettler.

WHEREFORE, Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to Myron Clark Lee II; and that all other Orders be entered as the Court may deem proper.
