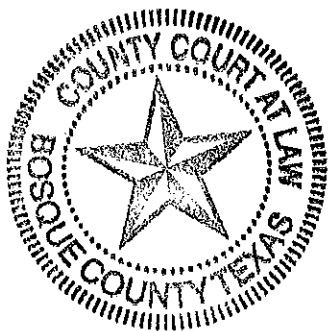

**APPLICATION TO PROBATE WILL AND  
FOR ISSUANCE OF LETTERS TESTAMENTARY**

TO THE HONORABLE JUDGE OF SAID COURT:

BRANDY MICHELLE POWERS BRUNER ("Applicant"), furnishes the following information to the Court in support of this Application for the probate of the Will of QUATA E. POWERS ("Decedent"), and for issuance of Letters Testamentary:

1. Applicant, BRANDY MICHELLE POWERS BRUNER is an individual interested in this Estate and is domiciled in and residing in California. BRANDY MICHELLE POWERS BRUNER will appoint a Texas agent for service of citation. BRANDY MICHELLE POWERS BRUNER may be served with citation at her address at 17 Birchwood, Irvine, California 92681. The last three digits of the social security number of BRANDY MICHELLE POWERS BRUNER are 246. The last three digits of the California driver's license number of BRANDY MICHELLE POWERS BRUNER are 417. The last three digits of the social security number of QUATA E. POWERS are 701. The last three digits of the driver's license number of QUATA E. POWERS are 067.

2. Decedent died on January 24, 2020 at Fort Worth, Tarrant County, Texas, at the age of 97 years. Decedent's domicile at the time of her death was Bosque County, Texas.

3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of her death.

4. Decedent owned property described generally as real and personal property, personal effects and household goods of a probable value of \$100,000.00.

5. Decedent left a valid Will dated January 31, 2019, which was never revoked. A true and correct copy of the Will is filed with the Court. The Will, will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

6. A necessity exists for the administration of the Estate, specifically to distribute the estate to the devisees.

7. After the date of the Will, no child was born to or adopted by Decedent.

8. No marriage of the Decedent was ever dissolved after the will was made.

9. Decedent's Will names RONALD H. POWERS to serve as Independent Executor. RONALD H. POWERS is residing in a nursing home and due to his mental and physical condition is unable to serve as Executor. The Will names as successor Executrix BRANDY MICHELLE POWERS BRUNER to serve and act independently without bond or other security. BRANDY MICHELLE POWERS BRUNER is not disqualified by law from serving as such or from accepting Letters Testamentary, and is entitled to such letters.

10. BRANDY MICHELLE POWERS BRUNER appoints Norman Horner, a resident of the state of Texas, of 607 Navajo Trail, Hamilton, Texas 76531 as resident agent to accept service of process in all actions or proceedings with respect to the estate.


11. No state, governmental agency of the state, nor charitable organization is named by the Will as a devisee.
