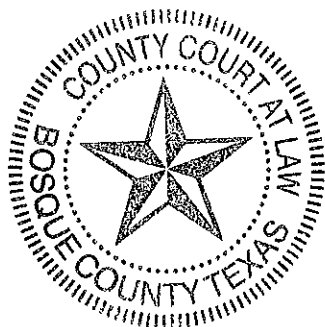

**AMENDED APPLICATION FOR PROBATE OF WILL AND  
LETTERS OF ADMINISTRATION WITH WILL ANNEXED**

**TO THE HONORABLE JUDGE OF SAID COURT:**

SHEILA POTTS ("Applicant") furnishes the following information to the Court concerning the Estate of MARVIN HOOD POTTS, Deceased ("Decedent") for the appointment of Administrator with Will Annexed, and for issuance of Letters of Administration with Will Annexed:

1. Applicant, is an individual interested in this Estate, and is domiciled in and residing in Texas. Applicant may be served with citation at 2200 Indian Trail, Kingsland, Texas 78637. Applicant is entitled to receive Letters of Administration with Will Annexed, and is not disqualified by law. Applicant is the sister-in-law and court-appointed guardian of Decedent. The last three digits of her social security number are 559, and the last three digits of her driver's license number are 452.

2. Decedent died testate on March 20, 2021 in Bosque County, Texas, at the age of 85 years. Decedent's domicile at the time of his death was Clifton Nursing and Rehabilitation LP, Farm Rd 3220, Clifton, Bosque County, Texas 76634. The last three digits of the social security number of Decedent are 929. Decedent did not have a driver's license at the time of his death.

3. This Court has jurisdiction and venue because Decedent was domiciled in Texas

and had a fixed place of residence in this County on the date of his death.

4. At the time of Decedent's death, Decedent owned personal property, generally described as cash, personal effects and household goods, with a probable value in excess of \$350,000.00.

5. Decedent left a valid Will dated August 6, 2002, which was never revoked.

6. A true and correct copy of the Will is attached. The Will will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

7. The Will was self-proved in the manner prescribed by law.

8. The subscribing witnesses to the Will are as follows: NELL SKELTON and SHEILA WILHELMI.

9. The Will named UDANIA JONES to serve as Executor, but UDANIA JONES is deceased, having died in 2013. The Will also named STEVEN JONES to serve as Executor, but STEVEN JONES is unwilling to accept appointment as Executor. The Will does not name any other Executor.

10. No children were born to or adopted by Decedent after the date of the Will.

11. At the time of his death, Decedent was not married.

12. No marriage of the Decedent was ever dissolved after the will was made.

13. Neither the state, a governmental agency of the state, nor a charitable organization is named by the Will as a devisee.

14. Administration of this Estate is necessary because the Court should partition the Estate among the distributees.

15. There is no need for the appointment of appraisers.

**WHEREFORE**, Applicant prays that citation issue as required by law to all persons interested in this Estate; that Applicant be appointed Administrator with Will Annexed; that Letters of Administration with Will Annexed be issued to Applicant; and that all other Orders be entered as the Court may deem proper.
