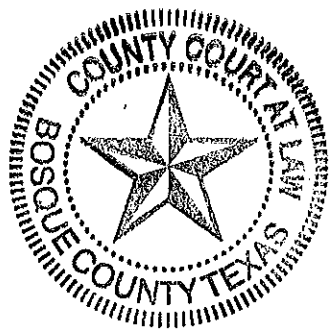



7. At the time of his death, Decedent was not married. Decedent was divorced from Cheryl Hoelscher on July 8th, 1985.


