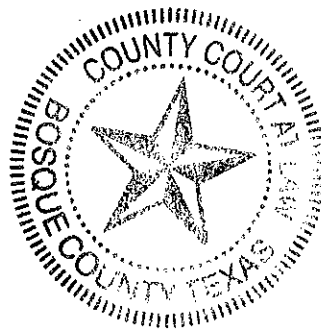

APPLICATION FOR PROBATE OF WILL
AND FOR ISSUANCE OF LETTERS TESTAMENTARY

TO THE HONORABLE JUDGE OF SAID COURT:

DEANNA ROBERTSON, being the same person as DEANNA CLARK, MICHAEL GILSON and KEVIN CLARK (“Co-Applicants”) furnishes the following information to the Court for the probate of the written Will of RUBY J. MARCKEL, (“Decedent”) and for issuance of Letters Testamentary to Applicant:

1. Co-Applicants, DEANNA ROBERTSON, being the same person as DEANNA CLARK, MICHAEL GILSON and KEVIN CLARK individuals interested in this Estate, domiciled and residing at the following:

DEANNA ROBERTSON, being the same person as DEANNA CLARK, 109 W. Denmark, Walnut Springs, Tx 76690; The last three digits of, DEANNA ROBERTSON’s, (being the same person as DEANNA CLARK) social security number are xxx-xx-x091.

MICHAEL GILSON, 291 East Norway, Walnut Springs, Tx 76690; The last three digits of, MICHAEL GILSON’s social security number are xxx-xx-x335.

KEVIN CLARK, 122 W. Denmark, Walnut Springs, Tx 76690; The last three digits of, KEVIN CLARK’s social security number are xxx-xx-x864.

2. Decedent died on October 13, 2021 in Walnut Springs, Bosque County, Texas, at the age of 79 years. The last three digits of Decedent’s social security number are xxx-xx-x297.
3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence at, 117 E. Denmark, Walnut Springs, Texas 76690 in Bosque County on the date of Decedent’s death.

4. Decedent owned real and personal property described generally as a home, a vehicle, household goods, and personal effects, of a probable value in excess of \$50,000.00.
5. Decedent left a valid written Will ("Will") dated April 25, 2018 which was never revoked and is filed herewith.
6. The subscribing witnesses to the Will are Kent Bratcher whose present address is 113 W. River, Meridian, Texas 76665 and Lori Jackson whose present address is 416 D. Street, Meridian, Texas 76665 and the Will is self proved.
7. No child or children were born to or adopted by Decedent after the date of the Will.
8. Decedent was a widow at the time of her death and had three (3) children, all of whom survived her, who are the Co-Applicants herein.
9. No marriage of the Decedent was dissolved after the date of the Will (See Section 256.052 Estates Code) except by the death of the Decedent's Husband.
10. A necessity exists for the administration of this estate.
11. Decedent's Will named Co-Applicants to serve as Co-Independent Executors without bond or other security and Co-Applicants would not be disqualified by law from serving as such or from accepting Letters Testamentary, and Co-Applicants would be entitled to such Letters.
12. Decedent's Will did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

Co-Applicants pray that citation issue as required by law to all persons in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to Co-Applicants as Co-Independent Executors without bond; and that all other orders be entered as the Court may deem proper.
