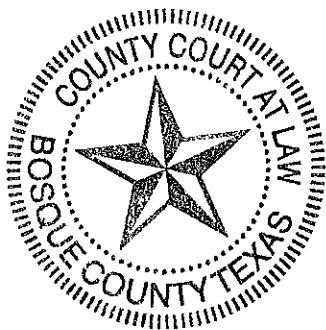



ACCOUNT FOR FINAL SETTLEMENT

LINDA STRADER, Guardian of the Person and Estate of NANCY STRADER ("Ward") files this Account for Final Settlement in accordance with Sections 1204.101 and 1204.102 of the Texas Estates Code and shows the Court the following:

I.

LINDA STRADER was appointed guardian of this estate by order of this court dated December 4, 2018. Since qualifying, she has administered this estate in accordance with the provisions of the Texas Estates Code.

II.

There is no further need for administration of this Estate, because the Ward died October 27, 2021. This Account For Final Settlement covers the period from August 3, 2021 to November 19, 30, 2021, and is accompanied with proper vouchers in support of each item not previously reported to the Court. The total value of the Estate at the beginning of this accounting period was \$122,865.00 as shown on the last Annual Account filed by the Guardian of this Estate.

III.

No property belonging to this Estate has come into the hands of the Guardian which has not been previously reported to the Court.

IV.

No claims against the estate have been presented to the Guardian during this accounting period.

V.

No changes have occurred in the property of the Estate during this accounting period which have not been previously reported by the Guardian of this Estate.

THEREFORE, the Guardian requests that citation and notice be issued and served as required by law; that, after a hearing, the Court audit, settle, and approve this Account for Final Settlement; that upon the delivery of the assets to those entitled to receive them, the Guardian shall apply to this Court asking for this Guardianship of the Person and Estate to be closed; and enter such further Orders as the Court deems proper.

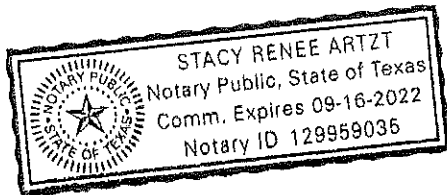
