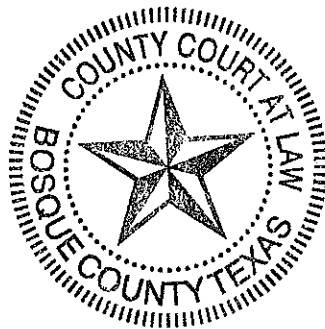


All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.

**APPLICATION FOR PROBATE OF WILL AND ISSUANCE OF LETTERS
TESTAMENTARY FOR AN INDEPENDENT ADMINISTRATION**

MARY D. HARKCOM, "Applicant", furnishes the following information for the probate of the written will of LEWIS F. HARKCOM, Decedent, and requests the court for probate of the following described will and for issuance of letters testamentary to Applicant:

1. This court has jurisdiction and venue because decedent was domiciled in Walnut Springs, Bosque County, Texas and had a fixed place of residence in this county on the date of Decedent's death.
2. Applicant is an individual interested in the Estate, domiciled in and residing at 133 Ave. A., Walnut Springs, Bosque County, TX 76690, whose social security number is xxx-xx-0358 and Texas Driver's License Number is XXXXX683.
3. Decedent died on September 11, 2021, in Bosque County, Texas, at the age of 74. Four years have not elapsed since Decedent's death. Decedent's Social Security Number is XXX-XX-9146.
4. Decedent resided at 133 Ave. A., Walnut Springs, Bosque County, TX 76690, at the time of his death.
5. Decedent owned personal property described generally as cash, an automobile, household goods, and miscellaneous personal effects, etc., of a probable value in excess of \$10,000.00.
6. Decedent left a valid written will ("will") dated February 8, 2018, which was never revoked. The will was executed by the Decedent with the formalities and solemnities and under the circumstances required by law to make the will a valid will. A true and correct copy of the original Will is filed with this Application and made a part hereof, and is offered for probate as the Last Will and Testament of the Decedent.

7. The will was signed by the decedent, and the subscribing witnesses to the will. Their names are:

8. No child or children were born to or adopted by decedent after the date the will was signed by the Decedent.

9. Decedent was married to MARY D. HARKCOM at the time of his death.

10. Decedent's Will named the Applicant, MARY D. HARKCOM to serve without bond or other security as Independent Executor.

11. Applicant is not disqualified at law from serving in that capacity or from accepting letters testamentary. Applicant is therefore entitled to the letters.

12. A necessity exists for the administration of this Estate.

13. Applicant requests that no other action be had in this cause in relation to the settlement of the decedent's Estate other than the probating and recording of the decedent's will and the return of an inventory, appraisement and list of claims of the decedent's Estate.

14. Applicant respectfully requests the court to waive the appointment of appraisers regarding the valuation of the Estate.

this estate other than the probating and recording of the Will and a return of an inventory, appraisal and list of claims of the estate, and that such other and further orders be entered as the court may deem necessary and proper.
