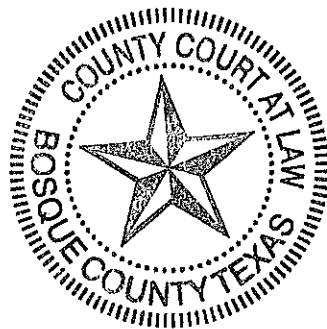

**APPLICATION FOR PROBATE OF WILL
 AND ISSUANCE OF LETTERS TESTAMENTARY**

To the Honorable Judge of the Court:

Carla Tracine Anderson, *Applicant*, furnishes the following information to the Court for the probate of the written Will of **Larry Wayne Anderson**, *Decedent*, and for issuance of *Letters Testamentary*:

1. Applicant is an individual interested in this estate, domiciled in and residing at 2399 FM 182, Clifton, Bosque County, Texas 76634. The last three digits of Applicant's Social Security and Texas driver's license numbers are 597 and 328, respectively.
2. Decedent died on September 28, 2021, in Providence Health Center, Waco, McLennan County, Texas, at the age of 76 years. The last three digits of Decedent's Social Security number and driver's license numbers are 352 and 505.
3. This Court has jurisdiction and venue because Decedent resided in this county at the time of death.
4. Decedent owned real and personal property described generally as real estate in Bosque County, Texas, a partnership interest, investment and bank accounts, vehicles, household goods and personal effects of a probable value of less than \$500,000.00.
5. Decedent left a valid, written Will dated March 3, 2006, *the Will*, which was never revoked and is filed in this cause.

6. The subscribing witnesses to the Will were Kim Bevels and Billy Joe Anz, Sr., who, at the time of the Will's execution resided near Clifton, in Bosque County, Texas. The Will was made self-proved in the manner prescribed by law.

7. Decedent was married twice:

- A. Decedent's first marriage was to Beth Anderson (now Blakeley), whom he divorced in 1990 in Bosque County, Texas. Of this marriage, only two children were born:
 - A.1. Anthony Wayne Anderson, currently an adult residing in or near Pancake, Coryell County, Texas; and
 - A.2. James Brian Anderson, currently an adult residing in or near Clifton, Bosque County, Texas.
- B. Decedent's only other marriage was to Carla Tracine Anderson (Applicant).

No other child was ever born to Decedent, adopted by Decedent, or taken into Decedent's home with the understanding of adoption.

None of Decedent's marriages were dissolved after the date of the Will.

8. A necessity exists for administration of this estate.

9. Neither Texas, nor any governmental agency of Texas, nor any charitable organization is named in the Will as a devisee. The Will's sole beneficiary is Decedent's surviving spouse, Carla Tracine Anderson (Applicant).

10. Decedent did not apply for or receive Medicaid benefits on or after March 1, 2005.

11. Decedent's Will named Applicant to serve without bond or other security as Independent Executor, and Applicant would not be disqualified by law from serving as such or from accepting *Letters Testamentary*, and Applicant would be entitled to such Letters.

12. Decedent's Will (paragraph 2.3.) grants the Independent Executor full power and authority over Decedent's assets, including the power to sell, manage and dispose of Decedent's property.

13. Pursuant to *Texas Estates Code Section 256.052(b)*, no information required for this Application has been omitted.

Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that *Letters Testamentary* be issued to Applicant; and that all other orders be entered as the Court may deem proper.
