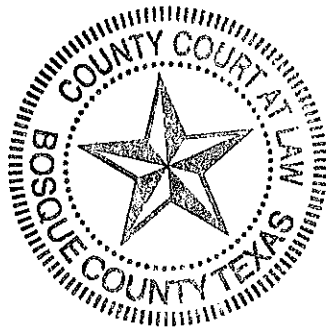

**APPLICATION TO PROBATE WILL AND

TO THE HONORABLE JUDGE OF SAID COURT:

Kelly Rae Olson ("Applicant"), furnish the following information to the Court in support of this Application for the probate of the Will of Kristi Lyn Hearrell ("Decedent"), and for issuance of Letters Testamentary:

1. Applicant, Kelly Rae Olson, is an individual interested in this Estate, being domiciled in and residing in Bosque County, Texas. Kelly Rae Olson's address for service of citation is 238 CR 2650, Walnut Springs, Bosque County, Texas 76690. The last three digits of the social security number of Kelly Rae Olson are 648. The last three digits of the driver's license number of Kelly Rae Olson are 643.

2. Decedent died on August 18, 2021, Tarrant County, Texas, at the age of 53. Decedent's domicile at the time of his death was in Walnut Springs, Bosque County, Texas. The last three digits of the social security number of Decedent are 894. The last three digits of the driver's license number of Decedent are 420.

3. This Court has jurisdiction and venue is proper because Decedent's principal property was situated in Bosque County, Texas, at the time of her death.

4. Decedent owned property described generally as real estate, cash, personal effects and household goods of a probable value in excess of \$620,699.00.

5. Decedent left a valid Will dated October 20, 2017, which was never revoked. A true and correct copy of the Will is attached. The Will will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

6. A necessity exists for the administration of the Estate.

7. After the date of the Will, no child was born to or adopted by Decedent.

8. No marriage of the Decedent was ever dissolved after the will was made.

9. Decedent's Will named Kelly Rae Olson to serve as Independent Executrix to serve without bond or other security. Kelly Rae Olson resides in Walnut Springs, Bosque County, Texas. Kelly Rae Olson is not disqualified by law from serving as such or from accepting Letters Testamentary, and is entitled to such letters.

10. No state, governmental agency of the state, nor charitable organization is named by the Will as a devisee.

11. The Will was made in the manner prescribed by law and the subscribing witnesses to the Will are Thomas Oliver Jr., and Donald Trester.

WHEREFORE, Applicants pray that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to Kelly Rae Olson; and that all other Orders be entered as the Court may deem proper.
