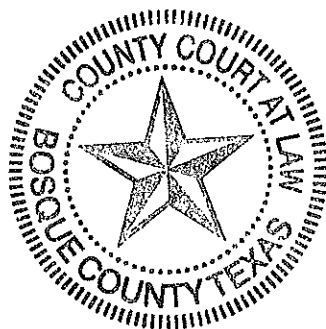

**APPLICATION TO PROBATE A HOLOGRAPHIC WILL AND  
FOR ISSUANCE OF LETTERS OF ADMINISTRATION  
PURSUANT TO SECTION 401.002(b) OF THE TEXAS ESTATES CODE**

**TO THE HONORABLE JUDGE OF SAID COURT:**

Marvin E. Singleton, IV, a/k/a Meson Singleton ("Applicant"), furnishes the following information to the Court in support of this Application for the probate of the Will of Nancy Lynn Singleton a/k/a Nancy Brown Singleton ("Decedent"), and for issuance of Letters of Administration pursuant to Section 401.002(b) of the Texas Estates Code:

1. Applicant Marvin E. Singleton, IV, a/k/a Meson Singleton is an individual interested in this Estate, being domiciled in and residing in Texas. Marvin E. Singleton, IV, a/k/a Meson Singleton's address for service of citation is 673 County Road 2200, Iredell, Texas, 76649. The last three digits of the social security number of Marvin E. Singleton, IV, a/k/a Meson Singleton are 944. The last three digits of the driver's license number of Marvin E. Singleton, IV, a/k/a Meson Singleton are 612.

2. Decedent died on September 30, 2021, at Iredell, Bosque County, Texas, at the age of 56. Decedent's domicile at the time of her death was Iredell, Bosque County, Texas. The last three digits of the social security number of Decedent are 973. The last three digits of the driver's license number of Decedent are 883.

3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of her death.

4. Decedent owned property described generally as real estate, cash, personal effects and household goods of a probable value in excess of \$10,000.00.

5. Decedent left a valid Will dated April 20, 2013, which was never revoked.

6. A true and correct copy of the Will is attached. The Will will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

7. A necessity exists for the administration of the estate.

8. After the date of the Will, no child was born to or adopted by Decedent.

9. No marriage of the Decedent was ever dissolved after the will was made.

10. The Will named Marvin E. Singleton, III as Executor, however, Marvin E. Singleton, III signed a Declination to Serve as Executor, which will be filed with the Court under this cause number.

11. There exists a necessity for administration of the Estate, the only Distributee is Marvin E. Singleton, IV, a/k/a Meson Singleton and he agrees on the advisability of having an independent administration and also agrees that he, Marvin E. Singleton, IV, a/k/a Meson Singleton, should be appointed Independent Administrator without bond. The Distributee therefore requests that no action shall be had in the county court at law in relation to the settlement of the Decedent's estate other than the probating and recording of the Will and the return of an inventory, appraisalment and list of claims of the estate, or an affidavit in lieu of the inventory, appraisalment and list of claims. Marvin E. Singleton, IV, a/k/a Meson Singleton is not disqualified by law from serving as such or from accepting Letters of Administration and would be entitled to such letters.

12. No state, governmental agency of the state, nor charitable organization is named by the Will as a devisee.

13. The Will was wholly in the handwriting of the Decedent and Decedent's signature is subscribed thereto.

14. Marvin E. Singleton, IV, a/k/a Meson Singleton is the sole distributee of the Estate and is not required to receive notice under Section 401.004 of the Texas Estates Code because Marvin E. Singleton, IV, a/k/a Meson Singleton enters an appearance in Court with the filing of this Application. An independent administration of the Decedent's estate pursuant to Section 401.002(b) of the Texas Estates Code is advisable and in the best interests of the Decedent's estate and of the heir and distributee of the Decedent's estate.

**WHEREFORE**, Applicant prays that citation with respect to this Application for Independent Administration and Letters of Administration pursuant to Section 401.002(b) of the Texas Estates Code be issued and served as required by law to all persons interested in this Estate; that the Holographic Will be admitted to probate; that it be adjudged to be advisable and in the best interests of the Decedent's estate for Marvin E. Singleton, IV, a/k/a Meson Singleton to be appointed to serve as Administrator under the Will and under the provisions of Section 401.002(b) of the Texas Estates Code; that Letters of Administration be issued to Marvin E. Singleton, IV, a/k/a Meson Singleton; that pursuant to Texas Estates Code Section 401.005, bond be waived by the county court at law and that no action be had in this court in relation to the settlement of such estate other than the probating and recording of such Will and the return of an inventory, appraisement, and list of claims of such estate, or an affidavit in lieu of the inventory, appraisement and list of claims; and that all other Orders be entered as the Court may deem proper.
