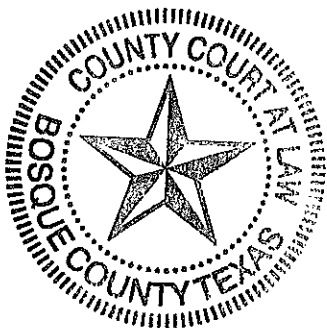

**APPLICATION FOR PROBATE OF WILL
AND ISSUANCE OF LETTERS TESTAMENTARY**

To the Honorable Judge of the Court:

Carolyn Ann (Pearcy) Bowen, *Applicant*, furnishes the following information to the Court for the probate of the written Will of **Robert L. Bowen**, *Decedent*, and for issuance of *Letters Testamentary*:

1. Applicant is an individual interested in this estate, domiciled in and residing at 177 CR 1292, Morgan, Bosque County, Texas 76671-3079. The last three digits of Applicant's Social Security and Texas driver's license numbers are 310 and 402, respectively.

2. Decedent died on November 1, 2021, at his home at 177 CR 1292, Morgan, Bosque County, Texas 76671-3079, at the age of 90 years. The last three digits of Decedent's Social Security number and driver's license numbers are 575 and 406.

3. This Court has jurisdiction and venue because Decedent resided in this county at the time of death.

4. Decedent owned real and personal property described generally as homestead in Bosque County, Texas, investment accounts, savings bonds, bank accounts, vehicles, household goods and personal effects of a probable value of less than \$500,000.00.

5. Decedent left a valid, written Will dated November 11, 1982, *the Will*, which was never revoked and is filed in this cause.

6. The subscribing witnesses to the Will were Harmon Caskey, Janie F. Salas and Patricia A. Krsak, who, at the time of the Will's execution, resided in or near Johnson County, Texas. The Will was self-proved in the manner prescribed by law.

7. Decedent was married four times:

A. Decedent's first marriage was to Frankie Sue Causey, whom he divorced in Louisiana in 1967. Four children were born of this marriage:

- Jerry Wayne Bowen, now an adult residing at 240 CR 1292, Morgan, Bosque County, Texas 76671;
- Debbie Ann Dean, now an adult residing at 1406 CR 2850, Kopperl, Texas 76652;
- Evelyn Kay Bowen, who died in an accident in about the year 1981 in Johnson County, Texas, without issue, never having married.
- Robert Murray Bowen, who died in 2015 leaving his only two children surviving him:
 - Jennifer Nicole Arthur, now adult residing at 210 CR 1291, Morgan, Bosque County, Texas 76671; and
 - Brittney Leigh Scott, now an adult residing at 2233 Pucker Street, Apartment #E, Stowe, Lamoille County, Vermont 05672.

B. Decedent's second marriage was to Marcella Faye (Hoover) Bowen, whom he divorced in 1977 in Johnson County, Texas. No children were born to or adopted by this marriage.

C. Decedent's third marriage was to Myrna Loy Arnold. No children were born to or adopted by this marriage, which was annulled in 1978 in Johnson County, Texas.

- D. Decedent's fourth marriage was to Carolyn Ann (Pearcy) Bowen, Applicant. No children were born to or adopted by this marriage, but Decedent's Will names Michael Edward Olier as Decedent's child. Michael Edward Olier is the child of Carolyn Ann (Pearcy) Bowen and is now an adult residing at 5171 Meadow Court, Fort Worth, Tarrant County, Texas 76112.

No other child was ever born to Decedent, adopted by Decedent, or taken into Decedent's home with the understanding of adoption.

None of Decedent's marriages were dissolved after the date of the Will.

8. A necessity exists for administration of this estate.

9. Neither Texas, nor any governmental agency of Texas, nor any charitable organization is named in the Will as a devisee. Applicant is the Will's sole beneficiary and is Decedent's surviving spouse.

10. Decedent did not apply for or receive Medicaid benefits on or after March 1, 2005.


11. Decedent's Will named Applicant to serve without bond or other security as Independent Executor, and Applicant would not be disqualified by law from serving as such or from accepting *Letters Testamentary*, and Applicant would be entitled to such Letters.

12. Decedent's Will grants the Independent Executor full power and authority over Decedent's assets.

13. Pursuant to *Texas Estates Code Section 256.052(b)*, no information required for this Application has been omitted.

Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that *Letters Testamentary* be issued to Applicant; and that all other orders be entered as the Court may deem proper.
