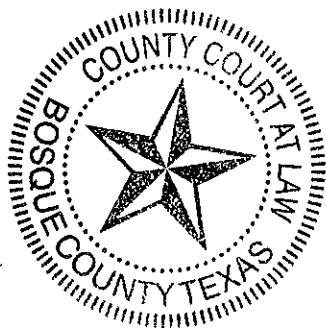

APPLICATION TO PROBATE WILL AND
FOR ISSUANCE OF LETTERS TESTAMENTARY
PURSUANT TO SECTION 401.002(a) OF THE TEXAS ESTATES CODE

TO THE HONORABLE JUDGE OF SAID COURT:

Lorraine Fisk ("Applicant"), furnishes the following information to the Court in support of this Application for the probate of the Will of Daniel Joseph Hemen ("Decedent"), and for issuance of Letters Testamentary pursuant to Section 401.002(a) of the Texas Estates Code:

1. Applicant Lorraine Fisk is an individual interested in this Estate, being domiciled in and residing in Texas. Lorraine Fisk's address for service of citation is 357 County Road 1700, Clifton, Texas 76634. The last three digits of the social security number of Lorraine Fisk are 077. The last three digits of the driver's license number of Lorraine Fisk are 501.

2. Decedent died on May 5, 2022, at Waco, McLennan County, Texas, at the age of 72 years. Decedent's domicile at the time of his death was Laguna Park, Bosque County, Texas. The last three digits of the social security number of Decedent are 661. The last three digits of the driver's license number of Decedent are 002.

3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of his death.

4. Decedent owned property described generally as real estate, cash, personal effects and household goods of a probable value in excess of \$1,000,000.00.

5. Decedent left a valid Will dated January 10, 2022, which was never revoked.

6. The Will will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

7. A necessity exists for the administration of the estate, specifically to provide for the distribution of decedent's estate.

8. After the date of the Will, no child was born to or adopted by Decedent.

9. No marriage of the Decedent was ever dissolved after the will was made.

10. Decedent's Will named Lorraine Fisk to serve as Executrix. Lorraine Fisk resides in Clifton, Bosque County, Texas. The Will does not provide for an independent administration. However, there exists a necessity for administration of the Estate, and the distributees agree on the advisability of having an Independent Administration and designates Lorraine Fisk as Independent Executrix and requests that no action shall be had in the county court in relation to the settlement of the Decedent's estate other than the probating and recording of the Will and the return of an inventory, appraisement and list of claims of the estate, or an affidavit in lieu of the inventory, appraisement and list of claims. Lorraine Fisk is not disqualified by law from serving as such or from accepting Letters Testamentary, and would be entitled to such letters.

11. No state, governmental agency of the state, or charitable organization is named by the Will as a devisee.


12. The subscribing witnesses to the Will are Patrick Williams, and Tommy Singleton.

13. David Hemen and Lorraine Fisk are the distributees of the Estate and are the only persons required to receive notice under Section 401.004 of the Texas Estates Code. David Hemen will file a Distributee's Consent to Application for Independent Administration and Waiver of Notice. An independent administration of the Decedent's estate pursuant to Section 401.002(a) of the Texas Estates Code is advisable and in the best interests of the Decedent's estate and of the heir and distributee of the Decedent's estate.

WHEREFORE, Applicant prays that citation with respect to this Application to Probate Will and for Issuance of Letters Testamentary pursuant to Section 401.002(a)

of the Texas Estates Code be issued and served as required by law to all persons interested in this Estate; that the Will be admitted to probate; that it be adjudged to be advisable and in the best interests of the Decedent's estate for Lorraine Fisk to be appointed to serve as Executrix under the Will and under the provisions of Section 401.002(a) of the Texas Estates Code; that Letters Testamentary be issued to Lorraine Fisk; and that no action be had in this court in relation to the settlement of such estate other than the probating and recording of such Will and the return of an inventory, appraisal, and list of claims of such estate, or an affidavit in lieu of the inventory, appraisal and list of claims; and that all other Orders be entered as the Court may deem proper.
