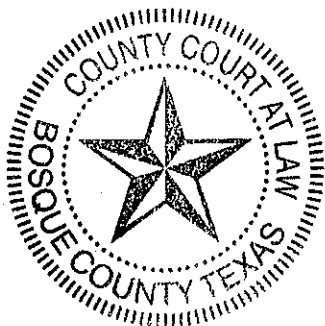


All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.

6. The subscribing witnesses to the Will were Jackie Kettler, who currently resides in Clifton, Bosque County, Texas & Patricia Ferguson, who currently resides near China Spring, Bosque County, Texas. The Will was self-proved in the manner prescribed by law.

7. Decedent was married two times.

Decedent's first marriage was to Anne Kittlitz, now deceased, which ended in divorce on February 18, 1965 in Delaware. Of this marriage, only one child was born:

Lena Nell (Lenell) Kittlitz, now an adult, residing at 19 Stratford Park, Bloomfield, Hartford County, Connecticut 06002.

Decedent's second marriage was to Linda Kittlitz, now deceased, which ended in divorce in about the year 1995 in Delaware. Of this marriage, only two children were born:

Liesel Marie Kittlitz, now an adult, residing at 3712 Sherwood Place, Lynchburg, Virginia 24503;

Rudolf Gottlieb Kittlitz, III, now an adult, residing at 418 Devonshire Drive, Bethlehem, Northampton County, Pennsylvania 18017; and

Theresa Anne Kittlitz, a child of Linda Kittlitz from a previous marriage, was adopted by Rudolf G. Kittlitz, Jr., now an adult, residing at 605A Hickory Lane, Seaford, Sussex County, Delaware 19973.

No other child was ever born to Decedent, adopted by Decedent, or taken into Decedent's home with the understanding of adoption.

None of Decedent's marriages were dissolved after the date of the Will.

10. Decedent did not apply for or receive Medicaid benefits on or after March 1, 2005.


