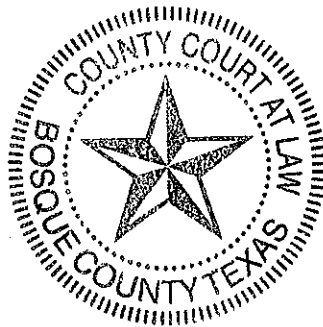

**APPLICATION FOR PROBATE OF WILL
AND ISSUANCE OF LETTERS TESTAMENTARY**

TO THE HONORABLE JUDGE OF SAID COURT:

Dawn Engler ("Applicant") furnishes the following information to the Court for the probate of the written Will of Donald Sydney Stone ("Decedent"), and for issuance of Letters Testamentary to Applicant:

1. Applicant is an individual interested in this Estate, domiciled in and residing at 1006 W. 2nd Avenue, Corsicana, TX 75110, the physical address at which service can be had on Applicant. The last three numbers of Applicant's driver's license number are 618, and the last three numbers of Applicant's Social Security number are 435.

2. Decedent died on May 9, 2022, in Bell County, Texas at the age of 60 years. The last three numbers of Decedent's driver's license number are 996, and the last three numbers of Decedent's Social Security number are 713.

3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence in this County on the date of death.

4. Decedent owned an interest in an RV Park, a home, real property, boat dock, checking account and miscellaneous personal property of a probable value in excess of \$1,000,000.

5. Decedent left a valid written will ("Will") dated July 8, 2011 which was never revoked and is filed herewith.

6. The names of the subscribing witnesses to the Will are Yvonne D. Townsend and Susan Decker. The Will was made self-proved in the manner prescribed by law.

7. No child or children were born to or adopted by Decedent after the date of the Will.

8. After the date of Decedent's Will, no marriage of Decedent was dissolved.

9. A necessity exists for the administration of this estate.

10. Decedent's Will named Applicant to serve without bond or other security as Independent Executrix, and Applicant would not be disqualified by law from serving as such or from accepting Letters Testamentary and Applicant would be entitled to such Letters.

11. The Will did not name either the State of Texas, a governmental agency of the State of Texas, nor a charitable organization as a devisee.

Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to Applicant; and that all other orders be signed as the Court may deem proper.
