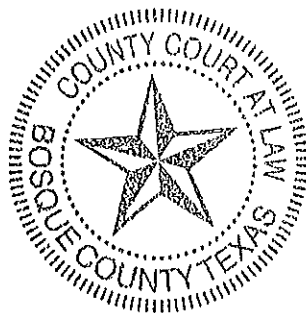




All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.

TO THE HONORABLE JUDGE OF SAID COURT:

TERESA MULHAUSEN FEDERSPIEL ("Applicant") furnishes the following information to the Court for the probate of the written Will of ELMER D. MULHAUSEN, ("Decedent") and for issuance of Letters Testamentary to Applicant:


1. Applicant, TERESA MULHAUSEN FEDERSPIEL is an individual interested in this Estate, domiciled and residing at 3812 Fordham Street, Frisco, Texas 75036. The last three digits of, TERESA MULHAUSEN FEDERSPIEL's social security number are xxx-xx-x815.
2. Decedent died on August 21, 2022 in Clifton, Bosque County, Texas, at the age of 94 years. The last three digits of Decedent's social security number are xxx-xx-x837.
3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence at, 321 CR 1630, Clifton, Texas 76634 on the date of Decedent's death.
4. Decedent owned real and personal property described generally as a home, a vehicle, household goods, and personal effects, of a probable value in excess of \$920,000.00.
5. Decedent left a valid written Will ("Will") dated November 15, 2021 which was never revoked and is filed herewith.
6. The subscribing witnesses to the Will are Angela Dinkle whose present address is 27155 FM 1602, Hico, Texas 76665 and Susan Godwin whose present address is P.O. Box 236, Meridian, Texas 76665 and the Will is self proved.
7. No child or children were born to or adopted by Decedent after the date of the Will.

8. Decedent was first married to CARRIE EVELYN CROW which marriage ended in the death of CARRIE EVELYN CROW. Four (4) children were born to that marriage who are JOHN C. MULHAUSEN, SHERYL L. MULHAUSEN, TERESA MULHAUSEN FEDERSPIEL and JAY DAVID MULHAUSEN. Decedent then married JO ANN ALBRIGHT MULHAUSEN, who predeceased the Decedent and one (1) child was adopted who is CRYSTAL ASHLEY CANTRELL. No other children were born to or adopted by Decedent.
9. No marriage of the Decedent was dissolved after the date of the Will (See Section 256.052 Estates Code) except by the death of the Decedent's wife.
10. A necessity exists for the administration of this estate.
11. Decedent's Will named Applicant to serve as Independent Executor without bond or other security and Applicant would not be disqualified by law from serving as such or from accepting Letters Testamentary, and Applicant would be entitled to such Letters.
12. Decedent's Will did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

Applicant prays that citation issue as required by law to all persons in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to Applicant as Independent Executor without bond; and that all other orders be entered as the Court may deem proper.
