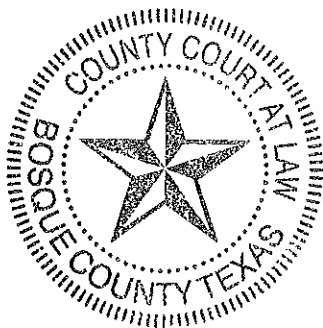

TO THE HONORABLE JUDGE OF SAID COURT:

Paula Diane Moore Shivers ("Applicant"), furnishes the following information to the Court in support of this application for the probate of the Will of BETTY ELAINE MOORE ("Decedent") as a Muniment of Title:

1. Paula Diane Moore Shivers, Applicant, is an individual interested in this Estate, and is domiciled in and residing in Texas. Paula Diane Moore Shivers's address for service of citation is 140 Champion Court, Weatherford, Texas 76087. The last three digits of the social security number of Paula Diane Moore Shivers are 155. The last three digits of the driver's license number of Paula Diane Moore Shivers are 291.

2. Decedent died on January 5, 2017 at Cranfills Gap, Bosque County, Texas, at the age of 79 years. Decedent's domicile at the time of her death was Cranfills Gap, Bosque County, Texas. The last three digits of the social security number of Decedent are 733. The last three digits of the driver's license number of Decedent are 439.

3. This Court has jurisdiction and venue because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of her death.

4. At the time of Decedent's death, Decedent owned real property in the State of Texas and personal property, generally described as real estate, cash, personal effects and

household goods, with a probable value in excess of \$100,000.00.

5. Decedent did not apply for and receive Medicaid benefits on or after March 1, 2005.

6. Decedent left a valid Will dated March 6, 2014, which was never revoked and is filed herewith.

7. Applicant is not in default for failing to present the Will for probate within four (4) years of the date of death of Decedent. Applicant unaware of necessity to probate.

8. The Will was self-proved in the manner prescribed by law.

9. The subscribing witnesses to the Will are as follows:

Witness: John A Hastings Jr.

10. The Will named Dalton Clark Moore as Independent Executor, who has filed a declination to serve. The Will names Paula Diane Moore Shivers whose residence address is 140 Champion Court, Weatherford, Texas 76087.

11. No children were born to or adopted by Decedent after the date of the Will.

12. No marriage of the Decedent was ever dissolved after the Will was made.

13. The name, age, marital status, address and relationship of each devisee under the Will of Decedent is as follows:

14. Neither the state, a governmental agency of the state, nor a charitable organization is named by the Will as a devisee.

15. Applicant has investigated the affairs of the Decedent and finds that to the best of Applicant's knowledge and belief, there are no unpaid debts owing by the Estate of the Decedent, exclusive of any debt secured by liens on real estate, and there is no necessity for administration on such Estate.

WHEREFORE, Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate as a Muniment of Title only; that the requirement for the filing of an Affidavit of Fulfillment of Terms of Will be waived; and that all other Orders be entered as the Court may deem proper.
