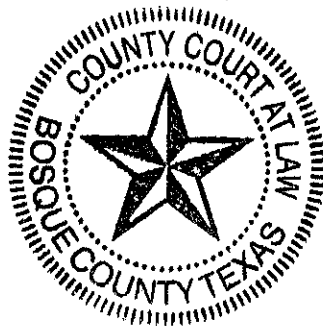

**APPLICATION FOR PROBATE OF WILL
 AND ISSUANCE OF LETTERS TESTAMENTARY**

To the Honorable Judge of the Court:

Paul E. Houston, *Applicant*, furnishes the following information to the Court for the probate of the written Will of **David Andrew Houston**, *Decedent*, and for issuance of *Letters Testamentary*:

1. Applicant is an individual interested in this estate, domiciled in and residing at 5833 S. Taft Way, Littleton, Jefferson County, Colorado 80127. The last three digits of Applicant's Social Security and Colorado driver's license numbers are 587 and 662, respectively.

2. Decedent died on October 1, 2022, in a nursing home, The Carlyle At Stonebridge Park, Southlake, Tarrant County, Texas 76092, at the age of 59 years. The last three digits of Decedent's Social Security number and Washington driver's license numbers are 349 and 6SB, respectively.

3. This Court has jurisdiction and venue because Decedent resided in this county at the time of death.

4. Decedent owned personal property described generally as bank accounts, vehicles, household goods and personal effects of a probable value of less than \$1,000,000.

5. Decedent left a valid, written Will dated May 13, 2010, *the Will*, which was never revoked and is filed in this cause.

6. The subscribing witnesses to the Will were Pauline Archuleta, who, at the time of the Will's execution resided at 290 Margarets Lane, Bernalillo, New Mexico 87004 and Julia Shrader, who, at the time of the Will's execution resided at 40 Scott Rd., Edgewood, New Mexico 87015. The Will was self-proved in the manner prescribed by law.

7. Decedent was never married.

No other child was ever born to Decedent, adopted by Decedent, or taken into Decedent's home with the understanding of adoption.

8. A necessity exists for administration of this estate.

9. Neither Texas, nor any governmental agency of Texas, nor any charitable organization is named in the Will as a devisee. The Will's equal share beneficiaries are Paul Edward Houston, an adult, residing at 5833 S. Taft Way, Littleton, Jefferson County, Colorado 80127, Joseph Alan Houston, an adult, residing at 1514 Pitt St. NE, Albuquerque, Bernalillo County, New Mexico 87112 and William Charles Houston, an adult, residing at 7111 Hazeltine Ave., Van Nuys, Los Angeles County, California 91405.

10. Decedent did not apply for or receive Medicaid benefits on or after March 1, 2005.


11. Decedent's Will named Applicant to serve without bond or other security as Independent Executor, and Applicant would not be disqualified by law from serving as such or from accepting *Letters Testamentary*, and Applicant would be entitled to such Letters.

12. Decedent's Will (paragraph V) grants the Independent Executor full power and authority over Decedent's assets, including the power to sell, manage and dispose of Decedent's property.

13. Pursuant to *Texas Estates Code Section 256.052(b)*, no information required for this Application has been omitted.

Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that *Letters Testamentary* be issued to Applicant; and that all other orders be entered as the Court may deem proper.
