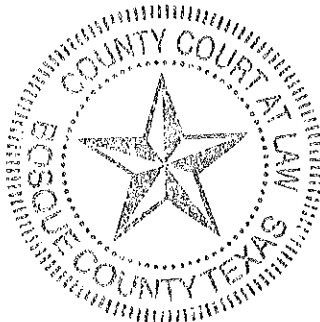

**APPLICATION FOR PROBATE OF WILL
AND ISSUANCE OF LETTERS TESTAMENTARY**

To the Honorable Judge of the Court:

Sally Fleming, Applicant, furnishes the following information to the Court for the probate of the written Will of **Florence Louisa Worley, Decedent,** and for issuance of *Letters Testamentary*:

1. Applicant is an individual interested in this estate, domiciled in and residing at 304 Wigley St., Robinson, McLennan County, Texas 76706. The last three digits of Applicant's Social Security and Texas driver's license numbers are 542 and 929, respectively.

2. Decedent died on August 24, 2022, at her home at 903 S Ave. J, Clifton, Bosque County, Texas 76634, at the age of 74 years. The last three digits of Decedent's Social Security number and driver's license numbers are 980 and 725, respectively.

3. This Court has jurisdiction and venue because Decedent resided in this county at the time of death and Decedent owned property interests in this county.

4. Decedent owned real and personal property described generally as homestead in Bosque County, Texas, a vehicle, household goods and personal effects of a probable value of less than \$275,000.00.

5. Decedent left a valid, written Will dated August 16, 2022, *the Will*, which was never revoked and is filed in this cause.

6. The subscribing witnesses to the Will were Patricia Ferguson, who currently resides in China Spring, Bosque County, Texas and Susan Vance, who currently resides in Meridian, Bosque County, Texas. The Will was self-proved in the manner prescribed by law.

7. Decedent was married four times.

A. Decedent's first marriage was to David L. Bragg which ended in divorce in the year 1966 in California. Of this marriage, only one child was born and was then adopted by Decedent's parents:

A.1. Russell C. Guisinger, now an adult, residing at 122A Royal Crest Dr., Seville, Medina County, Ohio 44273.

B. Decedent's second marriage was to Ronald F. Ullrich which ended in divorce in the year 1975 in California. No children were born of this marriage.

C. Decedent's third marriage was to John William Day which ended in divorce in the year 1982 in California. No children were born of this marriage.

D. Decedent's fourth and final marriage was to Vernon Joseph Worley, Jr. which ended in his death in 2012. No children were born of this marriage.

No other child was ever born to Decedent, adopted by Decedent, or taken into Decedent's home with the understanding of adoption.

None of Decedent's marriages were dissolved after the date of the Will.

8. A necessity exists for administration of this estate.

9. Neither Texas, nor any governmental agency of Texas, nor any charitable organization is named in the Will as a devisee. The Will's beneficiaries are Joshua Esch, an adult, who resides at 3455 Robin Road, Paris, Lamar County, Texas 75460, Jacob Fleming, an adult, who resides at 3405 Shady Creek Road, Chesterfield, Chesterfield County, Virginia 23234-3870, Jack Mullins, an adult, who resides at 2713 Carousel Drive, Murfreesboro, Rutherford County, Tennessee 37128 and Russell C. Guisinger, an adult, who resides at 122A Royal Crest Dr., Seville, Ohio 44273.

10. Decedent did not apply for or receive Medicaid benefits on or after March 1, 2005.

11. Decedent's Will named Applicant and Russell C. Guisinger to serve without bond or other security as Independent Executor, and Applicant would not be disqualified by law from serving as such or from accepting *Letters Testamentary*, and Applicant would be entitled to such Letters. Applicant anticipates that Russell C. Guisinger will sign a *Waiver of Appointment and Right to Letters Testamentary*.

12. Decedent's Will (paragraph 6) grants the Independent Executor full power and authority over Decedent's assets, including the power to sell, manage and dispose of Decedent's property.

13. Pursuant to *Texas Estates Code Section 256.052(b)*, no information required for this Application has been omitted.

Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that *Letters Testamentary* be issued to Applicant; and that all other orders be entered as the Court may deem proper.
