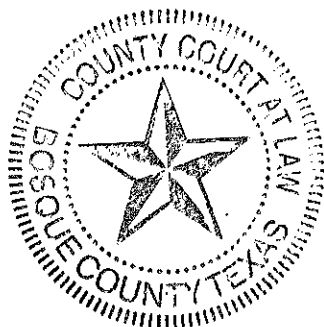

All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.



TO THE HONORABLE JUDGE OF SAID COURT:

DARRIN LEWIS TROXELL ("Applicant") furnishes the following information to the Court for the probate of the written Will of PAUL J. DELLINGER, ("Decedent") and for issuance of Letters Testamentary to Applicant:


1. Applicant, DARRIN LEWIS TROXELL, is an individual interested in this Estate, domiciled and residing at 301 W. Avenue F, Valley Mills, Texas 76689 The last three digits of, DARRIN LEWIS TROXELL's social security number are xxx-xx-x971. The last three digits of Applicant's Texas Driver's License are 911,
2. Decedent died on January 24, 2019 in Waco, McLennan County, Texas, at the age of 58 years. The last three digits of Decedent's social security number are xxx-xx-x350.
3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence at, 301 W. Avenue F, Valley Mills, Bosque County, Texas 76689 the date of Decedent's death.
4. Decedent owned real and personal property described generally as a home, a vehicle, household goods, and personal effects, of a probable value in excess of \$50,000.00.
5. Decedent left a valid written Will ("Will") dated May 30, 2017 which was never revoked and is filed herewith.
6. The subscribing witnesses to the Will are Philip Bradley Dellinger whose present address is 4201 Pembroke Parkway West, Colleyville, Texas 76034, Teresa Ann Holden, whose present address is 32509 FM 914, Dublin, Texas 76446 and Skyler LeMay whose present address is 301 W. Avenue F., Valley Mills, Texas 76689 and the Will is not self proved.

7. No child or children were born to or adopted by Decedent after the date of the Will.
8. Decedent was married once and one time only to Frances Louise Dell and one (1) child was born to that marriage. No other children were born to or adopted by Decedent.
9. No marriage of the Decedent was dissolved after the date of the Will (See Section 256.052 Estates Code) except by the death of the Decedent.
10. A necessity exists for the administration of this estate.
11. Decedent's Will did not name an Executor and Applicant requests that Applicant be appointed as Independent Administrator without bond or other security with the Will annexed. Applicant is qualified and would not be disqualified by law from serving as such or from accepting Letters of Independent Administration with Will annexed, and Applicant would be entitled to such Letters.
12. Decedent's Will did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

Applicant prays that citation issue as required by law to all persons in this Estate; that the Will be admitted to probate; that Letters of Independent Administration with Will annexed be issued to Applicant as Independent Administrator without bond; and that all other orders be entered as the Court may deem proper.
