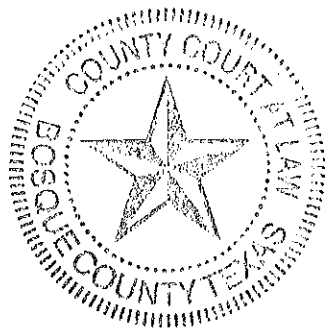

APPLICATION FOR PROBATE OF WILL

TO THE HONORABLE JUDGE OF SAID COURT:

Kanokkorn Chaudoin ("Applicant"), furnishes the following information to the Court in support of this application for the probate of the Will of Gene L. Chaudoin ("Decedent") as a Muniment of Title:

1. Kanokkorn Chaudoin, Applicant, is an individual interested in this Estate, and is domiciled in and residing in Texas. Kanokkorn Chaudoin's address for service of citation is 133 CR 1739, Clifton, Texas 76634. The last three digits of the social security number of Kanokkorn Chaudoin are 041. The last three digits of the Texas identification number of Kanokkorn Chaudoin are 131.

2. Decedent died on January 16, 2022 at Waco, McLennan County, Texas, at the age of 81 years. Decedent's domicile at the time of his death was 133 CR 1739, Clifton, Bosque County, Texas. The last three digits of the social security number of Decedent are 311. The last three digits of the driver's license number of Decedent are 120.

3. This Court has jurisdiction and venue because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of his death.

4. At the time of Decedent's death, Decedent owned real property in the State of Texas and personal property, generally described as real estate, cash, personal effects and household goods, with a probable value not in excess of \$100,000.00.

5. Decedent did not apply for and receive Medicaid benefits on or after March 1, 2005.

6. Decedent left a valid Will dated November 12, 2019, which was never revoked.

7. The Will cannot be produced in Court. After a diligent search, the original of Will cannot be located.

8. The contents of the Will are as follows: As shown on the photostatic copy of the Will which is being filed in with this Application.

9. Patricia Ferguson, a witness to the Will, will testify as to the execution and identity of the signature of the Deceased.

10. The Will named Russell Chaudoin as Independent Executor, whose residence address is 1037 Natalie Road, Warrenvive, SC 29851.

11. No children were born to or adopted by Decedent after the date of the Will.

12. No marriage of the Decedent was ever dissolved after the Will was made.

13. The name, age, marital status, address and relationship of each devisee under the Will of Decedent is as follows:



Applicant has investigated the affairs of the Decedent and finds that to the best of Applicant's knowledge and belief, there are no unpaid debts owing by the Estate of the Decedent, exclusive of any debt secured by liens on real estate, and there is no necessity for administration on such Estate.

WHEREFORE, Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate as a Muniment of Title only; that the requirement for the filing of an Affidavit of Fulfillment of Terms of Will be waived; and that all other Orders be entered as the Court may deem proper.
