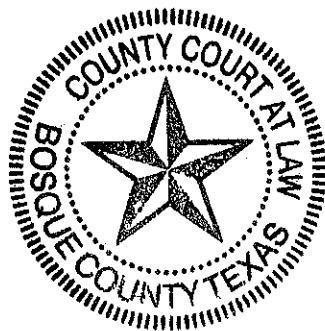

TO THE HONORABLE JUDGE OF SAID COURT:

EDWIN H. MCMAHON III ("Applicant"), furnishes the following information to the Court in support of this Application for the probate of the Will of EDWIN H. MCMAHON, JR ("Decedent"), and for issuance of Letters Testamentary:

1. Applicant, EDWIN H. MCMAHON, III, is an individual interested in this Estate, being domiciled in and residing in Texas. The last three numbers of EDWIN H. MCMAHON, III's social security number are 290 and the last three number of EDWIN H. MCMAHON, III's driver's license are 557. EDWIN H. MCMAHON, III's address for service of citation is 145 CR 1733, Clifton, Texas 76634.

2. Decedent died on January 27, 2022, at Fort Worth, Bosque County, Texas, at the age of 74 years. Decedent's domicile at the time of his death was 145 CR 1733, Clifton, Texas 76634, Bosque County, Texas. The last three numbers of the Decedent's social security number are 787 and the last three number of Decedent's driver's license are 219.

3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of his death.

4. Decedent owned property described generally as real estate, cash, personal effects and household goods of a probable value in excess of \$200,000.00.

5. Decedent left a valid Will dated December 4, 2014, which was never revoked. A true and correct copy of the Will is attached. The Will shall be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

6. A necessity exists for the administration of the Estate.

7. After the date of the Will, no child was born to or adopted by Decedent.

8. No marriage of the Decedent was ever dissolved after the will was made.

9. Decedent's Will named EDWIN H. MCMAHON, III, to serve as Independent Executor to act independently. EDWIN H. MCMAHON, III, resides in Bosque County, Texas. EDWIN H. MCMAHON, III, is not disqualified by law from serving as such or from accepting Letters Testamentary and is entitled to such letters.

10. No state, governmental agency of the state, nor charitable organization is named by the Will as a devisee.

11. The Will was made self-proved in the manner prescribed by law and the subscribing witnesses to the Will are Kent Bratcher and Linda Whitley.

WHEREFORE, Applicant prays that citation issue as required by law to all

persons interested in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to EDWIN H. MCMAHON, III; and that all other Orders be entered as the Court may deem proper.
