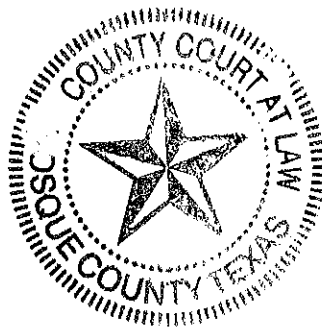


All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.

**APPLICATION TO DETERMINE HEIRSHIP AND
 FOR LETTERS OF INDEPENDENT ADMINISTRATION**

Applicant: Dena Griffin

Decedent: James Ray Walker

Applicant, Dena Griffin, is domiciled in Bosque County, and may be served at 181 CR 1282, Morgan, Bosque County, Texas 76671. Dena Griffin is a potential distributee of Decedent's intestate property seeking the appointment of an independent administrator under Section 401.003. The last three digits of Dena Griffin's Social Security number are 848. The last three digits of Dena Griffin's Texas driver's license are 891.

Applicant has standing to file this application in connection with the Estate of James Ray Walker, Deceased, to commence a proceeding to declare heirship and to determine whether there is a need for administration of Decedent's estate, and shows the Court as follows:

1. Facts and Place of Death

James Ray Walker, Decedent, died on October 8, 2022, in Waco, McLennan County, Texas.

2. Domicile of Decedent on Date of Death

Decedent, James Ray Walker, who died intestate, was domiciled at 258 CR 1140, Kopperl, Bosque County, Texas 76652.

3. Decedent's Identifying Information

The last three digits of Decedent's Social Security number are 098. The last three digits of Decedent's Texas driver's license are unknown.

4. Jurisdiction and Venue

This Court has jurisdiction over this matter and venue is proper because Decedent resided in this county and had a domicile or fixed place of residence in Texas.

5. Time Between Date of Death and Application

Four years have not elapsed since the date of Decedent's death and before the application.

6. Heirs

The name, physical address where service can be had, relationship to Decedent, minor status, and true interest in Decedent's estate of each of Decedent's heirs, and the only heirs, are as follows:

10. Existence of Will

To my knowledge, Decedent died intestate.

11. Property

Decedent owned real and personal property having an aggregate probable value of at least \$87,000.00

12. Medicaid Benefits

Decedent did not receive Medicaid benefits on or after March 1, 2005.

13. Required Information

Pursuant to Section 202.005(8) of the Texas Estates Code, no information required for this application has been omitted.

14. Qualification for Letters of Administration.

Dena Griffin is not disqualified by law from being appointed administrator without bond and from accepting letters of administration.

15. No Necessity for Appraisers


The appointment of any appraisers is not necessary for this estate.

16. Agreement on Independent Administration

As provided in Section 401.003, Texas Estates Code, all of the distributees of the estate agree on the advisability of having an independent administration and collectively designate Dena Griffin to serve as independent administrator. It is further requested that no other action shall be had in the probate court in relation to the settlement of this estate other than the return of an inventory, appraisalment, and list of claims of the decedent's estate.

Applicant requests that citation issue to all persons having any interest in Decedent's estate as required by law, that this Court determine who are Decedent's heirs and only heirs and their respective shares and interests in Decedent's estate, that there is a need for administration of Decedent's estate, that Dena Griffin receive letters of administration, that no appraisers are appointed, and that this Court enter all other orders it deems proper.

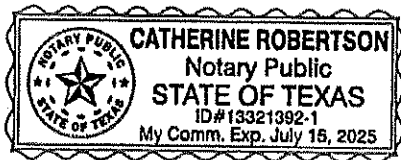
