Fees do not include additional services. Each citation issued is \$8. Posting of citation by Constable is \$30. Each personal service of citation by constable is \$90. Each personal service of citation by certified mail is \$90 plus certified mail fees. Each proposed order is \$2. Service by publication by Constable is \$75. If bond is required, there is a \$5 approval and filing fee.

Filer is responsible for requesting necessary additional services and paying appropriate fees, including citation, posting, personal service, orders, bond fees, etc, when required.
