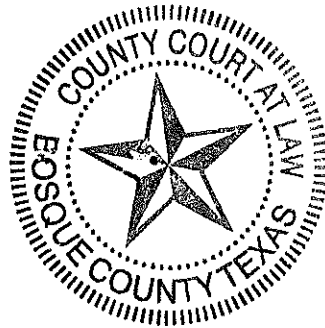


All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.

**APPLICATION FOR PROBATE OF WILL  
 AND ISSUANCE OF LETTERS TESTAMENTARY**

To the Honorable Judge of the Court:

**Clay Doye Scott**, *Applicant*, furnishes the following information to the Court for the probate of the written Will of **Patricia Scott Evans**, *Decedent*, and for issuance of *Letters Testamentary*:

1. Applicant is an individual interested in this estate, domiciled in and residing at P.O. Box 215, Kopperl, Bosque County, Texas 76652. The last three digits of Applicant's Social Security and Texas driver's license numbers are 863 and 557, respectively.

2. Decedent died on December 7, 2022, at Baylor Scott and White Medical Center-Temple, Temple, Bell County, Texas, at the age of 80 years. The last three digits of Decedent's Social Security number and driver's license numbers are 583 and 609, respectively.

3. This Court has jurisdiction and venue because Decedent resided in this county at the time of death and Decedent owned property interests in this county.

4. Decedent owned real and personal property described generally as homestead in Bosque County, Texas, bank accounts, vehicles, household goods and personal effects of a probable value of less than \$200,000.

5. Decedent left a valid, written Will dated March 7, 2018, *the Will*, which was never revoked and is filed in this cause.

6. The subscribing witnesses to the Will were Patricia Coy (now Ferguson), who currently resides near China Spring, Bosque County, Texas & Jessica Erickson, who currently resides near Clifton, Bosque County, Texas. The Will was self-proved in the manner prescribed by law.

7. Decedent was married twice.

Decedent's first marriage was to Wayland Scott that ended in his death in about the year 1997. No children were born of this marriage.

Decedent's second and final marriage was to Dan Jerome Evans that ended in his death on October 18, 2022. Of this marriage, no children were born.

No child was ever born to Decedent, adopted by Decedent, or taken into Decedent's home with the understanding of adoption.

None of Decedent's marriages were dissolved after the date of the Will.

8. A necessity exists for administration of this estate.

9. Neither Texas, nor any governmental agency of Texas, nor any charitable organization is named in the Will as a devisee. The Will's equal share beneficiaries are Clay Doye Scott, P.O. Box 215, Kopperl, Texas 76652 and Leslie Jo Scott. Leslie Jo Scott died in the year 2018 and was not married and had no children.

10. Decedent did not apply for or receive Medicaid benefits on or after March 1, 2005.


11. Decedent's Will named Applicant to serve without bond or other security as Independent Executor, and Applicant would not be disqualified by law from serving as such or from accepting *Letters Testamentary*, and Applicant would be entitled to such Letters. Decedent's first-named Executor, Dan Jerome Evans, died on October 18, 2022 at Providence Health Center in Waco, McLennan County, Texas.

12. Decedent's Will (paragraph VI) grants the Independent Executor full power and authority over Decedent's assets, including the power to sell, manage and dispose of Decedent's property.

13. Pursuant to *Texas Estates Code Section 256.052(b)*, no information required for this Application has been omitted.

Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that *Letters Testamentary* be issued to Applicant; and that all other orders be entered as the Court may deem proper.
