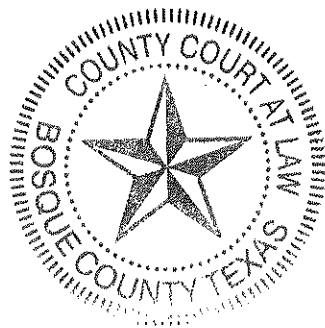

APPLICATION TO PROBATE A HOLOGRAPHIC WILL AND FOR ISSUANCE OF LETTERS TESTAMENTARY

TO THE HONORABLE JUDGE OF SAID COURT:

ANTHONY CLARK MCMILLAN ("Applicant"), furnishes the following information to the Court in support of this Application for the probate of the Will of NELSON C. MCMILLAN ("Decedent"), and for issuance of Letters Testamentary:

1. Applicant, ANTHONY CLARK MCMILLAN, is an individual interested in this Estate, being domiciled in and residing in Texas. ANTHONY CLARK MCMILLAN's address for service of citation is 211 N. Ave M, Clifton, Texas 76634. The last three digits of the social security number of ANTHONY CLARK MCMILLAN are 068. The last three digits of the driver's license number of ANTHONY CLARK MCMILLAN are 369.

2. Decedent died on January 11, 2023, at Clifton, Bosque County, Texas, at the age of 92 years. Decedent's domicile at the time of his death was Clifton, Bosque County, Texas. The last three digits of the social security number of Decedent are 777. The last three digits of the driver's license number of Decedent are 568.

3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of his death.

4. Decedent owned property described generally as real estate, cash, personal effects and household goods of a probable value in excess of \$25,000.

5. Decedent left a valid Will dated November 12, 2004, which was never revoked.

6. A true and correct copy of the Will is attached. The Will will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

7. A necessity exists for the administration of the Estate.

8. After the date of the Will, no child was born to or adopted by Decedent.

9. No marriage of the Decedent was ever dissolved after the will was made.


10. Decedent's Will named ANTHONY CLARK MCMILLAN to serve as Independent Executor to act independently. ANTHONY CLARK MCMILLAN resides in Clifton, Bosque County, Texas. ANTHONY CLARK MCMILLAN has not been convicted of any felony or otherwise disqualified by law from serving as such or from accepting Letters Testamentary, and is entitled to such letters.

11. No state, governmental agency of the state, nor charitable organization is named by the Will as a devisee.

12. The Will was wholly in the handwriting of the Decedent and Decedent's signature is subscribed thereto.

WHEREFORE, Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Holographic Will be admitted to probate; that Letters Testamentary be issued to ANTHONY CLARK MCMILLAN; and that all other Orders be entered as the Court may deem proper.
