THE LIMITS OF THE PROJECT ARE FROM FM 56 TO CR 3620. IN IMPROVING THIS INTERSECTION, THE STATE WILL NEED TO TAKE ON THEIR SYSTEM APPROXIMATELY 0.50 MILES OF CR 3615. WITH THE COUNTY'S APPROVAL IN THE SIGNED RESOLUTION, 0.50 MILES OF CR 3615 WILL BE TRANSFERRED FROM BOSQUE COUNTY TO THE STATE OF TEXAS BY A MINUTE ORDER AND COMMISSION APPROVAL. THE AREA OF 3615 IS

SHOWN ON THE ATTACHED MAP.

NOW THEREFORE BE IT FURTHER PROCLAIMED, THAT THE BOSQUE COUNTY COMMISSIONERS' COURT SUPPORTS THE REQUEST OF THE TEXAS DEPARTMENT OF TRANSPORTATION TO TRANSFER 0.50 MILES OF CR 3615 TO THE STATE OF TEXAS.
