## RESOLUTION TO APPROVE CONTRACT FOR COLLECTION OF DELINQUENT FINES & FEES DUE THE DISTRICT COURT & COUNTY COURT AT LAW OF BOSQUE COUNTY, TEXAS

- WHEREAS, the Commissioner's Court of Bosque County, Texas in an open meeting considered all the requirements related to a contingent fee contract as listed in Section 2254.1036(a)(1) Government Code as to a Contract for the Collection of Delinquent Fines and Fees due the District Court and County Court at Law of Bosque County, Texas; and,

- WHEREAS, the Commissioners' Court of Bosque County, Texas has determined that it is in the public interest to enter into a Contract for the Collection of Delinquent Fines and Fees Due the District Court and County Court at Law of Bosque County, Texas with the law firm of Inches Williams Virolla, Brages & Court & Grand County and County Court at Law of Bosque County, Texas with the law firm of Inches Williams Virolla, Brages & Court &
- WHEREAS, the agenda posted for this meeting of the Commissioners' Court of Bosque County, Texas contains an agenda item for the consideration of entering into a contingent fee contract in accordance with section 2254.1036(a)(1), Government Code.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS' COURT OF BOSQUE COUNTY, TEXAS:

- 1. That the facts and recitations contained in the preamble of this Resolution are hereby found and declared to be true and correct.
- 2. That the proposed Contract for the Collection of Delinquent Fines and Fees due the District Court and County Court at Law of Bosque County, Texas with Drawy Yuselka, Bragg + Aller PC, is hereby approved.
- 3. That the County Judge is hereby authorized to execute said Contract for the Collection of Delinquent Fines and Fees due the District Court and County Court at Law of Bosque County, Texas.
