Public Nuisance Definition

- (13) Definition of a "Junked Vehicle" Means a vehicle that is self-propelled and:
 (1) does not have lawfully attached to it:
 (a) an un-expired license plate; or
 (b) a valid motor vehicle inspection certificate; and

 - (2)
 - (a) wrecked, dismantled or partially dismantled, or discarded; or(b) inoperable and has remained inoperable for more than:
 - - (i) (ii) 72 consecutive hours, if vehicle is on public property; or 30 consecutive days if vehicle is on private property
