APPLICATION FOR PROBATE OF WILL AS MUNIMENT OF TITLE

To the Honorable Judge of the Court:

Norma Sue Riscky, *Applicant*, furnishes the following information to the Court for the probate of the Will of Stanford Beal Riggs a/k/a "Pete" Riggs, *Decedent*, as a Muniment of Title:

- 1. Applicant is an individual interested in this Estate domiciled and residing at 1829 Adams Lane, Azle, Parker County, Texas 76020-1847. The last three digits of Applicant's Social Security number and Texas driver's license are one and 381, respectively.
- 2. Decedent died on June 2, 2016 at Weatherford Regional Medical Center in Weatherford, Parker County, Texas, at the age of 94 years. On his date of death, Decedent resided with his daughter, Ellen Joy (Malone) Allen in Weatherford; however, his homestead was located at 129 PR 2400 Iredell, Bosque County, Texas. The last three digits of Decedent's Social Security number are 028. Decedent no longer has a driver's license.
- 3. This Court has jurisdiction and venue because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of death.
- 4. Decedent owned real and personal property generally described as his homestead and acreage out of the J. McCullough Survey A0519, Bosque County, Texas, and personal effects with a probable value of less than \$300,000.00.

- 5. Decedent did receive Medicaid benefits on or after March 1, 2005, but Decedent's estate falls under one of the exemptions of the Texas Medicaid Recovery Program.
- 6. Decedent left a valid Will dated September 25, 1982, and a valid Codicil dated July 31, 2006, which were never revoked and are filed with this Application. On those dates Decedent was over the age of eighteen years and of sound mind.
- 7. The subscribing witnesses to the Will were Peggy Seidel and Bruce Knudson, whose current whereabouts are unknown, but who, at the time of the Will's execution, resided in or near Meridian, Bosque County, Texas. The subscribing witnesses to the Codicil were Jimmie Lou Lewis and Khristi Bowers, who currently reside in or near Meridian, Bosque County, Texas.  - A.2. Ronald Gerald Riggs survived this Decedent and died in January of 2019, leaving his only child surviving him:

- A.2.a. Susan Goodell, now an adult residing at 6106 North Hill Lane, Fort Worth, Tarrant County, Texas 76135-1319 (This sole descendant of Ronald Gerald Riggs takes his share because he survived Decedent.)
- A.3. Ellen Joy (Malone) Allen, now an adult residing at 117 Meandering Way, Weatherford, Parker County, Texas 76086-2723
- A.4. Norma Sue Riscky (Applicant), 1829 Adams Lane, Azle, Parker County, Texas 76020-1847.
- B. Decedent's second marriage was to Merle Riggs in about the year 1958. They divorced in 1965 in Tarrant County, Texas. No children were born of this marriage.
- C. Decedent's third marriage was to Ethelda Riggs who predeceased him on January of 2016. No children were born of this marriage.

No other child was born to Decedent, adopted by Decedent, and no marriage of Decedent was dissolved.

- 10. Neither the State of Texas nor a governmental agency nor a charitable beneficiary is named in the Will as a beneficiary. The Will's equal share beneficiaries are Decedent's step-son, his children and his niece:

- Norma Sue Riscky (Applicant), Decedent's daughter, an adult residing at 1829
 Adams Lane, Azle, Parker County, Texas 76020-1847; and
- **Diana Sue Tutor**, Decedent's niece, an adult residing at 7300 Pecan Court, Mansfield, Tarrant County, Texas 76063-4921.
