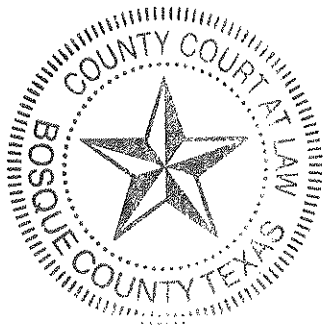


All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.

**APPLICATION FOR PROBATE OF
A WILL AND FOR LETTERS TESTAMENTARY**

MICHELLE MAREK HOPSON (Applicant) files this Application for Probate of a Copy of a Will and for Letters Testamentary, and show the Court the following:

1.

Applicant, MICHELLE MAREK HOPSON, is the daughter of the Decedent. She is domiciled at 8441 San Benito Way, Dallas, Texas 75218. The last three digits of her Social Security Number are 624, and the last three digits of her driver’s license number are 459.

2.

MARVIN RICHARD MAREK (Decedent) died on February 15, 2023, in the City of Clifton, Bosque County, Texas, at the age of 90 years. He was permanently domiciled at 160 County Road 1619, in the City of Clifton, Bosque County, Texas 76634. The last three digits of his Social Security Number were 960, and the last three digits of his driver’s license number were 421.

3.

At the time of his death, the Decedent was permanently domiciled in Bosque County, Texas, and his principal property was situated in Bosque County, Texas.

4.

The Decedent owned personal property, including bank accounts and cash in excess of \$50,000.00.

5.

The Decedent left a Will (Will) dated June 17, 2014. The Will was executed by the Decedent with the formalities and solemnities and under the circumstances required by law to make the same a valid Will. The subscribing witnesses to the Will were CAROL WOOLSTON and GENEVA B. TURNER, both residents of McLennan County, Texas. The Will was made self-proved in the manner prescribed by law. The Will provides that no bond or other security be required of the Applicant as Independent Executor and that no other action shall be had in the county court in relation to the settlement of the Decedent's estate other than the probate of the Will and the return of an inventory, appraisement, and list of claims of the estate, as required by law.

The original of the Will is filed with this Application, is made a part hereof, and is offered for probate as the Last Will and Testament of the Decedent.

6.

The Decedent was married three times. The first marriage was to ALICE LOUISE MAREK PROCTOR, and they divorced in 1961. The second marriage was to SARAH GRIZELTA MAREK, and she predeceased the Decedent on March 26, 1999. The third marriage was to DOLORES MILLER MAREK, and they never divorced. No marriage of the Decedent was dissolved after the date of the Will. No child or children was born to or adopted by the Decedent after the date of the Will.

7.

MICHELLE MAREK HOPSON was named as Independent Executor in the Will, to serve without bond. She is entitled to Letters Testamentary and is not disqualified by law from accepting Letters Testamentary.

8.

No charitable organization, state, nor any governmental agency of any state is named in the Will as a devisee.



There is a necessity for the administration of this estate. There is no necessity for court-appointed appraisers, and it is requested that none be appointed.

WHEREFORE, Applicant prays that citation with respect to this Application for Probate of Will and for Letters Testamentary be issued, addressed to all parties interested in the estate of the Decedent; that citation be served in the manner and for the length of time required by law; that Decedent's Will dated June 17, 2014, be admitted to probate; that Letters Testamentary be granted to the Applicant; that the Court order that the Applicant be the Independent Executor; that no appraisers be appointed; that no other action be had in this Court in relation to the settlement of such estate that the probating of the Will and the return of an inventory, appraisal, and list of claims of the estate as required by law; and that such other and further orders be entered as the Court may deem necessary and proper.
