Applicant requests that BECKY SUE HODGES be appointed Guardian of the Person and Estate of HILLARY ANN HODGES.



All persons interested in said cause are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting said request if they so desire.

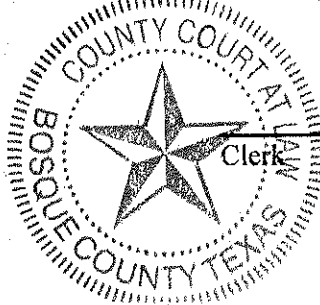

If you make such a request, you are responsible for the fees and costs associated with furnishing you the documents specified in the request. The clerk may require a deposit to cover the estimated costs of furnishing you with the request notice.

APPLICATION FOR APPOINTMENT OF GUARDIAN OF PERSON AND ESTATE

Becky Sue Hodges, Applicant, files this Application for Appointment of Guardian of Person and Estate pursuant to section 1101.001 of the Texas Estates Code on behalf of Hillary Ann Hodges, Proposed Ward, and shows the Court the following:

1. Proposed Ward is an adult female, whose birthday is 03/26/1977. Proposed Ward resides at 4466 FM 219, Clifton, Bosque County, Texas, and may be served with citation at that address.
2. Applicant is the biological mother of Proposed Ward and resides at 4466 FM 219, Clifton, Bosque County, Texas. Applicant desires to be appointed guardian of the person and estate of Proposed Ward. The last three digits of the social security number of Becky Sue Hodges are 732. The last three digits of the driver's license number of Becky Sue Hodges are 098. Becky Sue Hodges has used or been known as Becky Sue Schroeder. Applicant is eligible to receive letters of guardianship and is entitled to be appointed.



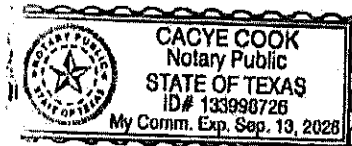


