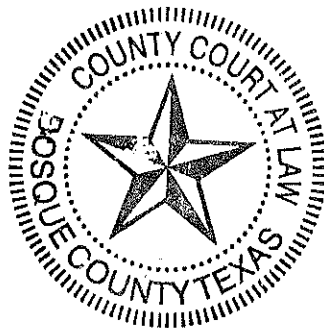

APPLICATION FOR TEMPORARY ADMINISTRATION

Debra Lynn McGill, ("Applicant"), furnishes the following information to the Court for the appointment of Applicant as Temporary Administrator in the Estate of Darrell Wayne Lankford, ("Decedent"), and for issuance of Letters of Temporary Administration:

1. Debra Lynn McGill's state of residence is Texas. Debra Lynn McGill's address for service of citation is 125 Single Oak Ln, Santo, Texas 76472. Applicant is entitled to Letters of Temporary Administration, and has not been convicted of a felony or otherwise disqualified by law from serving as Temporary Administrator. The last three digits of the social security number of Debra Lynn McGill are 648. The last three digits of the driver's license number of Debra Lynn McGill are 718.

2. Decedent died on March 24, 2021, in Meridian, Bosque County, Texas. The last three digits of the social security number of Decedent are 256.

3. This Court has jurisdiction and venue because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of his death.

4. The interest of Decedent's estate requires immediate appointment of a personal representative because it is necessary to protect the significant portion of Decedent's assets which are subject to spoilage.

5. The Temporary Administrator of this Estate should be given the following power:

(a) All powers of a Dependent Administrator, including the power to sell real estate and dispose of personal assets.

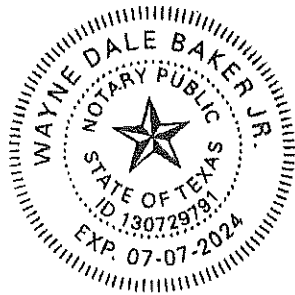


