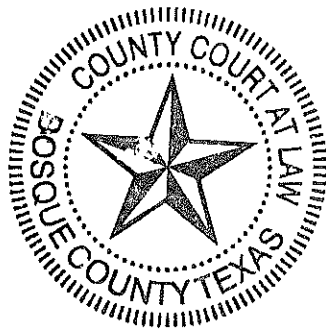

5. Decedent did not apply for and receive Medicaid benefits on or after March 1, 2005 to the best of knowledge of Applicant. However, Applicant has requested information from the Texas Medicaid Estate Recovery Program to determine if Decedent did apply for and receive Medicaid benefits on or after March 1, 2005.

6. Decedent left a valid Will dated July 21, 2015, which was never revoked.

7. The Will cannot be produced in Court. After a diligent search Applicant has been unable to locate the original of the Will.

8. A copy of the Will is attached hereto.

9. More than four years have lapsed since the date of Decedent's death. Applicant understood all the assets of Decedent had been transferred into the Ellawayne Lewis Trust (a Living Trust) established on December 19, 1993, amended May 19, 2015, and restated on July 21, 2015. Therefore, Applicant did not find it necessary to probate the Will of Ellawayne Lewis. However, Applicant has determined that there remains one piece of real property in the name of Ellawayne Lewis, Individually.

10. The Will named David Pachall as Independent Executor, whose residence address is 291 Jupiter Trail, Weatherford, Tx 76088.

11. No children were born to or adopted by Decedent after the date of the Will.

12. No marriage of the Decedent was ever dissolved after the Will was made.

13. The name and address of each devisee under the Will of Decedent is as follows:

- a **Name:** David Pachall, Trustee of the Ellawayne Lewis Trust  
**Address:** 291 Jupiter Trail, Weatherford, Tx 76088


14. The name of each person who would inherit as an heir of Decedent in the absence of a valid will is unknown to Applicant.

15. Neither the state, a governmental agency of the state, nor a charitable organization is named by the Will as a devisee.

16. Applicant has investigated the affairs of the Decedent and finds that to the best of Applicant's knowledge and belief, there are no unpaid debts owing by the Estate of the Decedent, exclusive of any debt secured by liens on real estate, and there is no necessity for administration on such Estate.

**WHEREFORE**, Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate as a Muniment of Title only; that the requirement for the filing of an Affidavit of Fulfillment of Terms of Will be waived; and that all other Orders be entered as the Court may deem proper.
