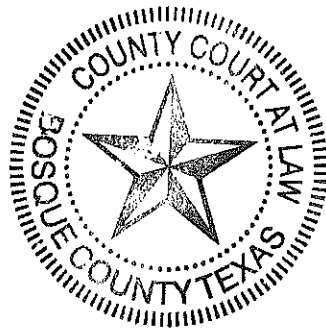

5. At the time of his death Decedent had never been married.


6. No children were born to or adopted by Decedent.



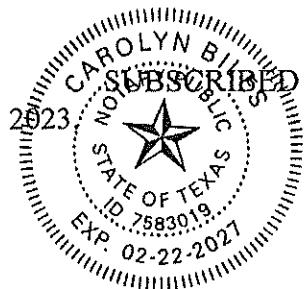
