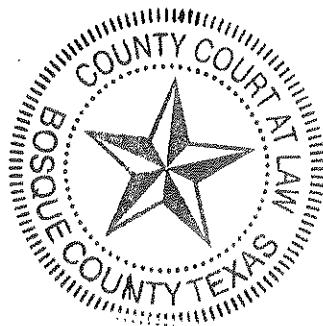

TO THE HONORABLE JUDGE OF SAID COURT:

Lane Christopher Davis and Marvin Burt Toler ("Applicants"), furnish the following information to the Court in support of this Application for the probate of the Will of Joann Toler Kretzer ("Decedent"), and for issuance of Letters Testamentary:

1. Applicant, Lane Christopher Davis, is an individual interested in this Estate, being domiciled in and residing in Texas. Lane Christopher Davis's address for service of citation is 100 Bluebonnet #140, Stephenville, Texas 76401. The last three digits of the social security number of Lane Christopher Davis are 089. The last three digits of the driver's license number of Lane Christopher Davis are 610.

2. Applicant, Marvin Burt Toler, is an individual interested in this Estate, being domiciled in and residing in Texas. Marvin Burt Toler's address for service of citation is 16055 S. US Hwy. 281, Hico, Texas 76457. The last three digits of the social security number of Marvin Burt Toler are 521. The last three digits of the driver's license number of Marvin Burt Toler are 108.

3. Decedent died on March 16, 2023, at Fort Worth, Tarrant County, Texas, at the age of 86 years. Decedent's domicile at the time of her death was Iredell, Bosque County, Texas. The last three digits of the social security number of Decedent are 817.

4. This Court has jurisdiction and venue is proper because Decedent was domiciled

in Texas and had a fixed place of residence in this County on the date of her death.

5. Decedent owned property described generally as real estate, cash, personal effects and household goods of a probable value in excess of \$10,000.00.

6. Decedent left a valid Will dated April 8, 2022, which was never revoked.

7. A true and correct copy of the Will is attached. The Will will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

8. A necessity exists for the administration of the Estate.

9. After the date of the Will, no child was born to or adopted by Decedent.

10. No marriage of the Decedent was ever dissolved after the will was made.

11. Decedent's Will named Lane Christopher Davis and Marvin Burt Toler to serve as Independent Co-Executors to act independently. Lane Christopher Davis resides in Stephenville, Erath County, Texas. Marvin Burt Toler resides in Hico, Erath County, Texas. Lane Christopher Davis and Marvin Burt Toler have not been convicted of any felony or otherwise disqualified by law from serving as such or from accepting Letters Testamentary and are entitled to such letters.

12. No state, governmental agency of the state, nor charitable organization is named by the Will as a devisee.

13. The Will was made self-proved in the manner prescribed by law and the subscribing witnesses to the Will are Kimberly Pack Wilson and Susan Wylie.

WHEREFORE, Applicants pray that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to Lane Christopher Davis and Marvin Burt Toler; and that all other Orders be entered as the Court may deem proper.
