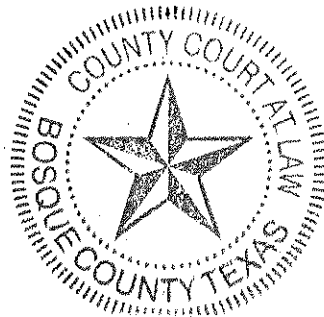

APPLICATION TO DECLARE HEIRSHIP

TO THE HONORABLE JUDGE OF SAID COURT:

CYNTHIA K. JOHNSON (the "Applicant"), furnishes the following information to the Court for the purpose of determining the heirship of the decedent, Gary Patrick Dahman (the "Decedent") and the respective interests of the heirs in the Estate of the Decedent:

1. Applicant is the surviving brother of the Decedent. Applicant's domicile and residence address is 185 Golden Crown Avenue, Henderson, Nevada 89002. The last three numbers of Applicant's Nevada driver's license are 421, and the last three digits of the Applicant's social security number are 601.

2. The Decedent died on December 3, 2022 in Clifton, Bosque County, Texas at the age of 73 years. The Decedent did not have a driver's license from any state at the time of his death. The last three numbers of Decedent's social security number are 365.

3. This Court has jurisdiction of this matter and venue herein is proper because Decedent was domiciled and had a fixed place of residence in this county on the date of death.

4. To the best of Applicant's knowledge, Decedent died intestate.

5. No administration is pending upon Decedent's estate, and none appears necessary. It is necessary and in the best interest of the estate for the Court to determine who are the heirs and only heirs of Decedent.

6. Decedent's family and marital history is as follows:

(a) Decedent was never married and had no children.

(b) Decedent's mother, Alice Williams Dahman, died on December 20, 2011.

(c) Decedent's father, Lawrence Albert Dahman, died on September 10, 1984.

(d) Decedent's parents had three children: (i) the Decedent, (ii) a daughter, Sherry Lee Hunley, who died on June 19, 2022, without descendants, and (iii) a daughter, the Applicant, Cynthia K. Johnson.

7. All children born to or adopted by Decedent have been listed. Each marriage of Decedent has been listed.

8. Applicant claims to be the owner of all of the Decedent's estate. The name and residence of all of Decedent's heirs all of whom are adults above the age of 25, the relationship of each heir to Decedent, and the true interest of the Applicant and of each of the heirs in the estate of Decedent are as follows:

9. At the time of Decedent's death, Decedent did not own any real property.

10. At the time of Decedent's death, Decedent owned the following personal property:

11. There are no debts owed by Decedent that are secured by liens on real estate, and there is no necessity for the administration of this estate.

12. This Application does not omit any information required by Texas Estates Code, Section 202.005.

WHEREFORE, PREMISES CONSIDERED, Applicant prays that citation issue as required by law to all persons interested in this estate; that an attorney ad litem be appointed to represent Decedent's unknown heirs and heirs whose whereabouts are unknown; that upon hearing hereof, this Court determine

and declare who are the heirs and only heirs of Decedent and their respective shares and interests in this estate; and that such other and further orders be signed as the Court may deem proper.

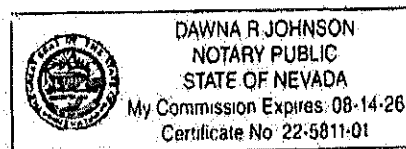
