Applicant requests that **MISTI MOSES** be appointed **Permanent Guardian of the Person and the Estate of ROWDY AIKEN HINDS**.



All persons interested in said cause are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting said request if they so desire.


You are notified that you have the right under Texas Estates Code Section 1051.252 (Texas Probate Code Section 632 (j)) to file with the clerk a written request that you be notified of any or all specifically designated motions, applications, or pleadings filed by any person, or by a person specifically designated in your request, relating to the application for the guardianship that has been filed or relating to any subsequent guardianship proceeding involving the ward after the guardianship is created, if any. If you make such a request, you are responsible for the fees and costs associated with furnishing you the documents specified in the request. The clerk may require a deposit to cover the estimated costs of furnishing you with the request notice.

The officer executing this Writ shall promptly post the same and make due return as the law directs.

**APPLICATION FOR APPOINTMENT OF PERMANENT
GUARDIAN OF THE PERSON AND ESTATE**

To the Honorable Judge of the Court:

Misti Moses, Applicant, makes this application for the appointment of Guardian of the Person and Estate of **Rowdy Aiken Hinds, an Adult, the Proposed Ward,** pursuant to *Texas Estates Code Section 1101.001,* and show the Court the following:

1. Alternatives. Alternatives to guardianship, available support and services that would avoid the need for guardianship were considered, however, no available alternatives were feasible to avoid the need for guardianship.

2. Proposed Ward. The Proposed Ward is a male who is eighteen (18) years old, born on August 9, 2004. He currently resides with his mother and step-father at 822 Bosque, Meridian, Bosque County, Texas 76665. The last three digits of his social security number is 476. The Proposed Ward does not have a driver's license. The Proposed Ward is currently in the care and custody of his parents.

Misti Moses holds a durable power of attorney for the Proposed Ward.

3. Parents. The Proposed Ward's mother is Misti Moses, 822 Bosque, Meridian, Bosque County, Texas 76665. The Proposed Ward's father is Lance Hinds, deceased on January 19, 2014 in Coleman County, Texas.

4. Other Interested Persons. The names, addresses and relationships to the Proposed Ward of those persons required to be listed in this Application by *Texas Estates Code Section 1101.001(13)* are as follows:

Mason Fuller, brother, 28 years of age, residing at 318 CR 606, Tuscola, Taylor County, Texas 79562; and

Madison Fuller, sister, 21 years of age, residing at 3825 Mapleshade Lane, Apt # 2412, Plano, Collin County, Texas 75075.

The Proposed Ward is not married and has no children.

5. Applicants. Applicant Misti Moses is the Proposed Ward's mother, whose address is shown above. Applicant is eligible by law to act as Guardian. The last three digits of Applicant's Social Security and driver's license numbers are 072 and 715, respectively.

Applicant desires to be appointed Guardian of the Person and Estate of the Proposed Ward. Applicant's interest in the appointment of a guardian is that the Proposed Ward needs a guardianship to allow Applicant (his mother) to continue to protect him from undue influence and provide for his care.

6. Venue. This Court has venue over these proceedings because the Proposed Ward and Applicant reside in Bosque County.

7. Incapacitation. The Proposed Ward is an adult and is incapacitated because of a mental condition. The nature of his incapacity is autism, speech impairment, intellectual disability and other health impairment (ADHD). The degree of his incapacity is partial, and the severity of his partial incapacity is moderate.

8. Appointment of Guardian. Applicant requests that the Court appoint her Guardian of the Person and Estate of Rowdy Aiken Hinds, to see to the care of all of Proposed Ward's personal, physical and financial needs and limit the rights of the

Proposed Ward in the areas listed below, and grant the appointed Guardian the following powers and authority:

Make complex business, managerial, and financial decisions for the Proposed Ward;

Manage the Proposed Ward's accounts and funds;

Make decisions regarding living arrangements;

Make decisions regarding marriage;

Assist with daily activities;

Consent to medical and dental treatment;

Consent to psychological and psychiatric treatment.

The following facts and reasons support the request for appointment of a Guardian and the granting of the requested powers: The Proposed Ward is diagnosed with autism, a speech impairment, intellectual disability and other health impairment (ADHD) that limit his decision-making ability, responding to environmental stimuli and demonstrating his need and wants and requires attention for his safety and health. See the *Physician's Certificate* attached to this Application.


9. Notice & Citation. Notice and issuance of service of citation addressed to the Proposed Ward may be served on him at 822 Bosque, Meridian, Bosque County, Texas 76665.

Prayer

Applicant prays that

- A hearing on this Application be set;
- Applicant be appointed Guardian of the Person and Estate of Rowdy Alken Hinds, an Adult;
- The Court's Order appointing Applicant as Guardian be effective upon her taking the Oath as required by law;
- Upon the Guardian's qualification, the Clerk of this Court shall issue *Letters of Guardianship* to Misti Moses;
- The Court appoint an attorney and/or guardian ad litem to represent the Ward;
- The Court enter any other Orders it deems necessary.

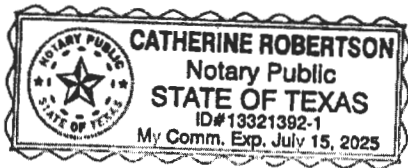
