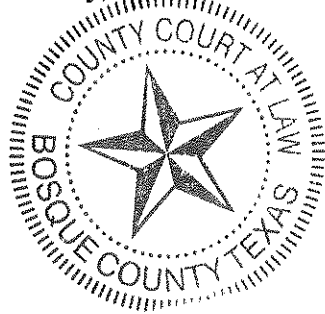

**TO THE HONORABLE JUDGE OF SAID COURT:**

LINDA SUE MCGINNIS ("Applicant"), furnishes the following information to the Court in support of this Application for the probate of the Will of WILLIAM GAYLE MCGINNIS ("Decedent"), and for issuance of Letters Testamentary:

1. Applicant, LINDA SUE MCGINNIS, is an individual interested in this Estate, being domiciled in and residing in Texas. LINDA SUE MCGINNIS's address for service of citation is 204 CR 1764, Clifton, Texas 76634. The last three digits of the social security number of LINDA SUE MCGINNIS are 325. The last three digits of the driver's license number of LINDA SUE MCGINNIS are 049.

2. Decedent died on January 8, 2023, at Clifton, Bosque County, Texas, at the age of 77 years. Decedent's domicile at the time of his death was Clifton, Bosque County, Texas. The last three digits of the social security number of Decedent are 216. The last three digits of the driver's license number of Decedent are 772.

3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of his death.

4. Decedent owned property described generally as cash, personal effects and household goods of a probable value in excess of \$25,000.00.

5. Decedent left a valid Will dated November 21, 2022, which was never revoked.

6. A true and correct copy of the Will is attached. The Will will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

7. A necessity exists for the administration of the Estate.

8. After the date of the Will, no child was born to or adopted by Decedent.

9. No marriage of the Decedent was ever dissolved after the will was made.


10. Decedent's Will named LINDA SUE MCGINNIS to serve as Independent Executor to act independently. LINDA SUE MCGINNIS resides in Clifton, Bosque County, Texas. LINDA SUE MCGINNIS has not been convicted of any felony or otherwise disqualified by law from serving as such or from accepting Letters Testamentary, and is entitled to such letters.

11. No state, governmental agency of the state, nor charitable organization is named by the Will as a devisee.

12. The Will was made self-proved in the manner prescribed by law and the subscribing witnesses to the Will are P. James Rainey, and J. Trenton McMillan.

WHEREFORE, Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to LINDA SUE MCGINNIS; and that all other Orders be entered as the Court may deem proper.
