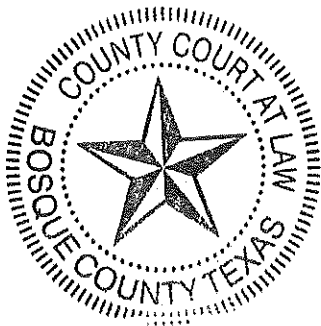

APPLICATION FOR PROBATE OF WILL AND ISSUANCE OF LETTERS TESTAMENTARY

TO THE HONORABLE JUDGE OF SAID COURT:

Arthur Lee Filler, II ("Applicant") furnishes the following information to the Court for the probate of the Will of Walter Jackson Filler ("Decedent") and for issuance of letters testamentary to Applicant as Independent Executor:


1. Applicant is an individual interested in this estate, is a surviving son of the Decedent, and is domiciled in and residing at 512 E. Ave C, Valley Mills, Bosque County, TX 76689 The last three digits of Applicant's Social Security number are XXX-XX-X591 and the last three digits of Applicant's driver's license are Texas XXXXX001.
2. Decedent died on March 20, 2023, in McLennan County, TX, at the age of 84 years. The last three digits of Decedent's Social Security number are XXX-XX-X269, and the last three digits of Decedent's driver's license are Texas XXXXX443.
3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence in this county on the date of death.
4. Decedent owned real estate, household goods, personal effects, and other property of a probable value in excess of \$25,000.
5. Decedent left a valid will ("Will") executed on November 4, 2013, which was never revoked. A copy of the Will is filed herewith. The original will be subsequently delivered to the Clerk of this Court.
6. The subscribing witnesses to the Will are Susan Bekkelund and Glenda Tennihill. The Will was made self-proved in the manner prescribed by Texas law.
7. No child or children were born to or adopted by Decedent after the date of the Will.
8. After the date of Decedent's Will, no marriage of Decedent was dissolved.
9. A necessity exists for the administration of this estate.

10. The Will did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

11. The Will named J. Devin Alsup as Independent Executor, and Applicant Arthur Lee Filler, II, as successor Independent Executor, each to serve without bond or other security. J. Devin Alsup has executed a Declination to Serve as Independent Executor which is filed herewith. Applicant, as successor Independent Executor, is not disqualified by law from serving as such or from accepting letters testamentary, and Applicant is entitled to such letters.

Applicant prays that citation issue as required by law to all persons interested in this estate; that the Will be admitted to probate; that letters testamentary be issued to Applicant; and that all other orders be signed as the Court may deem proper.
