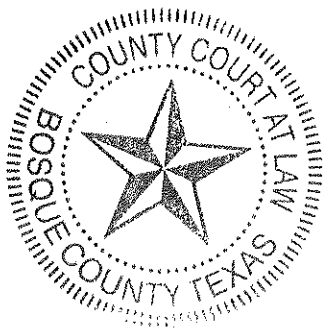

**APPLICATION TO PROBATE WILL AND
FOR ISSUANCE OF LETTERS TESTAMENTARY**

TO THE HONORABLE JUDGE OF SAID COURT:

NINA DIANE RICHTER (“Applicant”), furnishes the following information to the Court in support of this Application for the probate of the Will of Ernestine P. Koonsman (“Decedent”), and for issuance of Letters Testamentary:

1. Applicant, NINA DIANE RICHTER, is an individual interested in this Estate, being domiciled in and residing in Texas. Applicant’s address for service of citation is P.O. Box 20932, Waco, Texas 76702. The last 3 digits of Applicant’s social security number and driver’s license number are 070 and 622, respectively.

2. Decedent died on April 30, 2023, in Waco, McLennan County, Texas, at the age of 84 years. Decedent’s domicile at the time of her death was 2121 W Hwy 6, Waco, McLennan County, Texas. The last 3 digits of Decedent’s social security number are 013. Decedent did not have a valid driver’s license at the time of her death.

3. This Court has jurisdiction and venue is proper because Decedent was domiciled in Texas and had a fixed place of residence in this County when she last had capacity to establish her own residence. Additionally, the court established and retains jurisdiction over Decedent by guardianship proceeding in Cause No. G08244.

4. Decedent owned property is described generally as cash, personal effects, and household goods of a probable value in excess of \$500,000.00.

5. Decedent left a valid Will dated May 20, 2020, which was never revoked.

6. A true and correct copy of the Will is attached. The original will be delivered to the County Clerk pursuant to the Texas Rules of Civil Procedure.

7. A necessity exists for the administration of the Estate, specifically distribution of assets and wrapping up matters relating to the Decedent’s guardianship.

8. After the date of the Will, no child was born to or adopted by Decedent.

9. No marriage of the Decedent was ever dissolved after the will was made.


10. Decedent's Will named NINA DIANE RICHTER to serve as Independent Executor to act independently. NINA DIANE RICHTER resides in Woodway, McLennan County, Texas, and has not been convicted of any felony or otherwise disqualified by law from serving as such or from accepting Letters Testamentary, and is entitled to such letters.

11. No state, governmental agency of the state, nor charitable organization is named by the Will as a devisee.

12. The Will was made self-proved in the manner prescribed by law and the subscribing witnesses to the Will are Kent Bratcher and James Hardin.

WHEREFORE, Applicant prays that citation issue as required by law to all persons interested in this Estate; that the Will be admitted to probate; that Letters Testamentary be issued to NINA DIANE RICHTER; and that all other Orders be entered as the Court may deem proper.
