**APPLICATION TO DETERMINE HEIRSHIP
AND
APPLICATION FOR INDEPENDENT ADMINISTRATION**

TO THE HONORABLE JUDGE OF SAID COURT:


The undersigned Applicant files this Application to Determine Heirship and Application for Independent Administration of the property and Estate of VICKY LYNN TURNER, Deceased, and for Letters of Independent Administration:

1. To Applicant’s best knowledge and belief, VICKY LYNN TURNER, Applicant’s wife, “Decedent”, died without a Will.
2. Applicant, JIMMY W. TURNER, is an individual interested in this Estate, domiciled in and residing at 309 E. Avenue G. Meridian, Texas 76665. The last three (3) digits of the Social Security number of JIMMY W. TURNER are XXX-XX-X148.
3. Decedent died on April 24, 2023, in Broward County, Florida, at the age of 66 years.
4. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence at 309 E. Avenue G., Meridian, Bosque County, Texas, 76665 on the date of her death.
5. Decedent owned real and personal property described generally as cash, vehicles, and personal effects, of a probable value in excess of \$50,000.00.
6. The Decedent was married one time and one time only to JIMMY W. TURNER, the Applicant herein and four (4) children were born to or adopted by the marriage who are TIMOTHY TURNER, HEATHER TURNER, ELIZABETH ALLEN and KELLY TURNER.
7. A necessity exists for the Independent Administration of Decedent’s property and Estate to consider payment of claims, to set aside allowances, to collect insurance proceeds, and to resolve other matters which require the authorization of a personal representative in settling Decedent’s estate, and to sell any property that may need to be sold or liquidated without further order of the Court.


8. Applicant is not disqualified by law from serving as Independent Administrator of Decedent's Estate.
9. Applicant requests that this Court, upon notice and hearing as required by law, appoint Applicant as Independent Administrator, without bond, for an order authorizing him to sell property of the Estate without further Order of the Court, and for such other and further orders appropriate to this Estate.
10. Applicant requests that the Court order that no other action by the Court is necessary except for the filing of an Inventory or an Election Not to File an Inventory as may be allowed by law and that the Court further order that Applicant may sell property of the estate of the Decedent without further order of this Court.
11. Since Applicant survived the Decedent and since all of the Decedent's children were children of both the Applicant and the Decedent and since the Decedent died without a Will, Applicant is entitled to 100% of the estate of the Decedent since all of the property of the Decedent was community property and since the Applicant and Decedent have been married for 28 years.

Applicant prays that citation issue as required by law to all persons in this Estate including citation upon unknown heirs; that Letters granting Independent Administration without bond be issued to Applicant; that the Court declare JIMMY W. TURNER, TIMOTHY TURNER, HEATHER TURNER, ELIZABETH ALLEN and KELLY TURNER as the only heirs of the Decedent; and that all other Orders be entered as the Court may deem proper.




