All persons interested in said estate are hereby cited to appear before said Honorable Court at said above mentioned time and place by filing a written answer contesting such application should they desire to do so.



TO THE HONORABLE JUDGE OF SAID COURT:

MARGARET CATHERINE JONES FORREST ("Applicant"), furnishes the following information to the Court in support of this application for the probate of the holographic Will of DAVID H. JONES ("Decedent") as a Muniment of Title:

1. MARGARET CATHERINE JONES FORREST, Applicant, is an individual interested in this Estate, and is domiciled in and residing in Texas. MARGARET CATHERINE JONES FORREST's address for service of citation is 79 Oakmont Circle, Belton, Texas 76513. The last three digits of the social security number of MARGARET CATHERINE JONES FORREST are 314. The last three digits of the driver's license number of MARGARET CATHERINE JONES FORREST are 811.

2. Decedent died on April 29, 2022 at Morgan, Bosque County, Texas, at the age of 69 years. Decedent's domicile at the time of his death was Morgan, Bosque County, Texas. The last three digits of the social security number of Decedent are 313.

3. This Court has jurisdiction and venue because Decedent was domiciled in Texas and had a fixed place of residence in this County on the date of his death.

4. At the time of Decedent's death, Decedent owned real property in the State of Texas and personal property, generally described as real estate, cash, personal effects and household goods, with a probable value in excess of \$25,000.

5. Decedent did not apply for and receive Medicaid benefits on or after March 1, 2005.

6. Decedent left a valid Will dated December 16, 2019, which was never revoked and is filed herewith.

7. The Will was wholly in the handwriting of the Decedent, and Decedent's signature is subscribed thereto.

8. The Will did not name an executor.

9. No children were born to or adopted by Decedent after the date of the Will.


10. No marriage of the Decedent was ever dissolved after the Will was made.

11. Neither the state, a governmental agency of the state, nor a charitable organization is named by the Will as a devisee.

12. Applicant has investigated the affairs of the Decedent and finds that to the best of Applicant's knowledge and belief, there are no unpaid debts owing by the Estate of the Decedent, exclusive of any debt secured by liens on real estate, and there is no necessity for administration on such Estate.

WHEREFORE, Applicant prays that citation issue as required by law to all persons interested in this Estate; that the holographic Will be admitted to probate as a Muniment of Title only; that the requirement for the filing of an Affidavit of Fulfillment of Terms of Will be waived; and that all other Orders be entered as the Court may deem proper.
