



APPLICATION TO DETERMINE HEIRSHIP

Applicant: Timothy Miller

Decedent: Michael Edward Hinote

Applicant, Timothy Miller, who may be served at 253 CR 3340, Clifton, Bosque County, Texas 76634, is a court-appointed conservator for minor distributees of Decedent's intestate property seeking the appointment of an independent administrator under *Section 401.003*. The last three digits of Timothy Miller's Social Security number are 565. The last three digits of Timothy Miller's Texas driver's license are 219.

Applicant has standing to file this application in connection with the Estate of Michael Edward Hinote, Deceased, to commence a proceeding to declare heirship and to determine whether there is a need for administration of Decedent's estate, and shows the Court as follows:

1. Facts and Place of Death

Michael Edward Hinote, Decedent, died on January 26, 2023, in Clifton, Bosque County, Texas. On the date of death, Decedent was 51 years old.

2. Decedent's Identifying Information

9. Property


Decedent owned real and personal property having an aggregate probable value of at least \$250,000.



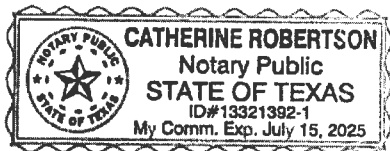
