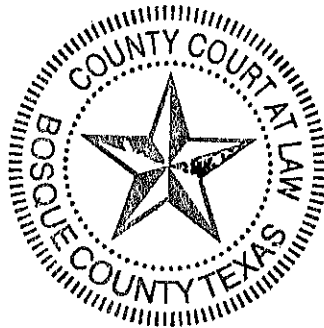

TO THE HONORABLE JUDGE OF SAID COURT:

Freddie Wayne Light Applicant, furnishes the following information to the Court for the probate of the written Will of Betty Ruth Light ("Decedent") as a muniment of title.

1. Applicant is an individual interested in this Estate, domiciled in and residing at 310 N. Avenue I, Clifton, Bosque County, Texas.
2. Decedent died May 27, 2023 in Bosque County, Texas at the age of 73 years.
3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence in this county on the date of death.
4. Decedent owned real and personal property described generally as home, cash, automobile, household goods, and personal effects of a value in excess of \$50,000.
5. Decedent left a valid written Will dated December 8, 2017, which was never revoked and is filed herewith.

7. No child or children were born to or adopted by Decedent after the date of the Will.
8. The Decedent never had a dissolution of marriage after the Will was made.
