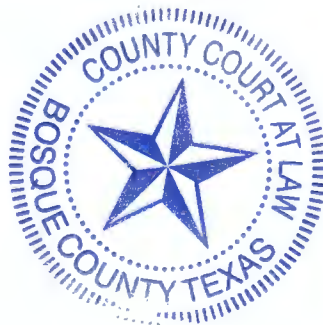

TO THE HONORABLE JUDGE OF SAID COURT:

Stephen E. Russell ("Applicant") furnishes the following information to the Court for the probate of the written Will of **Jacquelyn C. Linn, also known as Jacquelyn Connie Linn** ("Decedent") and for issuance of Letters Testamentary to Applicant:

1. Applicant is an individual interested in this estate, domiciled in Bosque County and residing at 256 County Road 1524, Morgan, Texas, 76671. The last four numbers of Applicant's social security number are: xxx-xx-1495; and the last three numbers of Applicant's Texas driver's license are: xxxxx521.

2. Decedent died on June 7, 2023 in her home located at 256 County Road 1524, Morgan, Bosque County, Texas, 76671, at the age of 81 years. Decedent's domicile at the time of her death was: 256 County Road 1524, Morgan, Bosque County, Texas, 76671. The last four digits of Decedent's social security number are: xxx-xx-9050.

3. This Court has jurisdiction and venue because Decedent was domiciled and had a fixed place of residence in this county on the date of death.

4. Decedent owned real and personal property described generally as homestead, other real property, household goods, and assorted personal effects of a

probable value in excess of \$50,000.00. There should be no lien levied against any of Decedent's property.

5. Decedent left a valid written will ("Will") dated September 7, 1988, which was never revoked and is filed herewith.

7. The Will was made self-proved in the manner prescribed by law.
8. No child or children were born to or adopted by Decedent after the date of the Will.
9. Decedent was an unmarried person (widow) on the date of death.
10. A necessity exists for the administration of this estate.
11. The Will named James I. Linn to serve without bond or other security as Independent Executor. However, James I. Linn is deceased and, by virtue thereof, Applicant is the named Successor Executor in the Will and should be appointed as the sole Independent Executor.

12. The Will named Stephen E. Russell, Robin D. Russell (deceased), Dana S. Ramirez (now known as Dana S. Zielinski), Cheryl Silva Linn, James M. Linn, and Vicki K. Linn-Vanderburgt, as the sole beneficiaries and devisees of Decedent's estate.

13. The Will did not name either the State of Texas, a governmental agency of the State of Texas, or a charitable organization as a devisee.

14. Applicant requests that no other action shall be had by the Court other than the filing and approval of an Inventory, Appraisal and List of Claims, or an Affidavit in Lieu of Inventory, Appraisal and List of Claims, on behalf of Decedent's estate.

WHEREFORE, Applicant prays that citation be issued, as required by law, to all persons interested in this estate; that the Will be admitted to probate; that Letters Testamentary be issued to Applicant; and that all other orders be signed as the Court may deem proper.
